- Resume screening project to accelerate screening for common cancers
  - Resumption of mammography, colonoscopy, lung and cervical to pre-pandemic rates
  - National data will be available (most effective ways to re-engage in cancer screenings)
- ASTHO project educational modules to address individual bias regarding recruiting patients to clinical trials from disparate populations

Dr. Mark Doescher: OUSCC

- Visit volume still low (reluctance to enter clinical setting (broaden screening accessibility and increasing public awareness)
- Clinical Trials:
  - African American Community Advisory Board Meeting (perception of experimentation)
  - Reality is that clinical trials are very important to make sure there are advancements in therapy (ways to build trust and confidence in participation is critical)
