PERSONNEL

<u>Business Manager</u>: The position was posted, interviews were held, and a candidate was selected. The candidate accepted the job, but days before this person was to start, the candidate decided not to take the position after all. An offer was made to another candidate, but she had just started a new position. We will be posting the position again and starting over the process. My continued thanks goes to Assistant Director Mark James for all of the extra work he has put in while this position has been vacant.

<u>Parent Partnership Board Program Coordinator</u>: We are thrilled to announce that Isabel Rodriguez has joined OCCY to serve in this position. She comes to us with years of experience serving parents while working at the Latino Community Development Agency.

<u>Freestanding Multidisciplinary Team Program Manager</u>: Sadly, Mr. Jimmy Widdifield, Jr. resigned at the end of May to take a position with the National Child Advocacy Center. We wish him continued success in his new role. We will be posting the position as quickly as possible.

OCCY PROGRAM HIGHLIGHTS

Post Adjudication Review Board - PARB (Keith Pirtle)

<u>Update on PARB Database</u>: Meetings continue to occur between the OU E-Team and PARB staff to fix glitches in the new database and create canned reports. This new system will provide information regarding the types of recommendations made to the court and the amount of time a child is out of the home. Currently, 30 out of the 43 PARBs are utilizing the new database.

<u>Calendar Year (CY) Information</u>: At the conclusion of Calendar Year 2021, there were 287 individual volunteers serving on 43 PARBs. There were two new PARBs created during that year in Pushmataha and Logan Counties. Unfortunately, the Muskogee County PARB became inactive during that year.

Number of Cases Closed: CDRB staff continue to make progress on setting up and closing cases. As the below table shows, a total of 75 cases were closed and a total of 57 cases were added to the database these past three months.

Office of Planning and Coordination - P&C (Danielle Dill) Upcoming Events:

- 1) In partnership with HARUV USA, P&C is hosting a "<u>Children of Incarcerated Workshop</u>" on June 24th in Tulsa. Keynote presenters include Dr. Nancy Correa of Texas Children's Hospital and Dr. Hilary Cuthrell of the University of Wisconsin. A special feature of the event will be a panel comprised of individuals who have had experiences either being incarcerated or having an incarcerated loved one.
- 2) A <u>fatherhood summit</u> is being planned for Friday, August 12th from 10:00 to noon. A virtual presentation titled "The Global Boy Crisis: Why Our Boys are Struggling and What We Can Do About It" will be given by author Dr. Warren Farrell.

<u>Parent Partnership Board</u>: Children's Trust Fund Alliance Consultants Kara Georgi, Edward Casillas, and Michael Huesca provided an in-person "Strategic Sharing" training for board

members in May. The goal of the training was to assist board members in crafting their parenting experiences into short, concise stories that would be useful in policymaking.

<u>The Homeless Children and Youth Steering Committee</u>: In April, 73 stakeholders joined the steering committee for a one-day strategic planning session facilitated by Falen LeBlanc and Amanda Aunko from the OU National Resource Center for Youth Services. <u>Children's Justice Act Grant for Training (CJAG)</u>: The third quarter report for the CJAG was submitted to the Oklahoma Advisory Task Force on Child Abuse and Neglect. Below is a summary of results. OCCY exceeded grant requirements of 25 trainings and two ChildFirst® Oklahoma trainings.

- 30 training events completed
- 58 unique sessions/topics
 - o 17 local trainers
 - 14 national trainers
- 87 sessions provided (includes 12 repeated topics)
- 2,483 participants
- 23 training events were provided virtually and 7 were provided in-person
- 209.50 hours of training provided

Freestanding Multidisciplinary Teams (Jimmy Widdifield, Jr.)

New Orientation Training: Mr. Widdifield collaborated with Carrie Little, Executive Director of Children's Advocacy Centers of Oklahoma, Inc., to finalize an orientation training curriculum for multidisciplinary teams. The training was provided to District Attorney District 16 and the Choctaw Nation on May 12.

<u>Special Recognition</u>: In April, Mr. Widdifield was awarded the Barbara L. Bonner Award for Distinguished Service by the Interdisciplinary Training Program on Child Abuse and Neglect at the Center on Child Abuse and Neglect, University of Oklahoma Health Sciences Center.

Board of Child Abuse Examiners (BCAE): Dr. Stockett continued development of training curriculum for child abuse medical examiner training, participated in Sexual Assault Nurse Examiner coordination and training, and developed training sessions for upcoming events. Makala Pittman and Dr. Stockett are working to schedule child abuse medical examiner trainings, which will highlight local medical providers, for District Attorney districts 6, 17, and 19 via the Children's Advocacy Centers and/or FSMDT in those districts.
