SPECIAL MEETING MINUTES

1. Call to Order and Roll Call

The meeting was called to order at 10:05 a.m. by Chairperson, Greg Delaney. Determination of quorum was established for members present and the board was in compliance with notice and agenda requirements of the Oklahoma Open Meeting Act. Members present in person: Sarah Herrian, Dr. Kalie Kerth, Lou Truitt-Flanagan, Melanie Johnson, and Jonette Dunlap. Members present via video conference: Dr. Greg Parks, Paula Cantrell, Lana Freeman, Greg Delaney, Lisa Buck, Christina Siemens, the Honorable Leah Edwards, Cindy Nocton, the Honorable Ryan Reddick, the Honorable Pat VerSteeg, Members present via phone: David Ross. Members not present: Dr. Carol Bridges, Sandy Brown, Deanna Chancellor, Tracy Otto, the Honorable Louis Duel, Daniel Herring, and the Honorable Bill Baze. 2. Introduction of Members and Guests, Public Comments

Lisa White from the University of Oklahoma (OU) was in attendance. No public comments were made.

3. Review and Approval of the Meeting Minutes of February 26, 2021 Discussion and Possible Action

Paula Cantrell motioned, and Lisa Buck seconded approve the minutes of the February 26, 2021, State Post Adjudication Review Advisory Board Meeting, and the majority of members present voted in the affirmative with four members abstaining. Motion passed.

4. Legislative Update

Jennifer Hardin, Legislative Liaison with OCCY, provided an update on OCCY's legislative requests for the 2021 Legislative session. The bills that moved forward to the next phase include House Bill (HB) 2311, HB 2312, HB2313, HB2317, and Senate Bill (SB) 987. SB 339 did not move to the next phase.

5. Commission Report

Dr. Kalie Kerth provided a synopsis of the makeup, function, and duties of OCCY's Board of Commissioners.

6. Vote on PARB Representative to OCCY Board of Commissioners

Discussion and Possible Action

Keith Pirtle reported that Dr. Kerth currently represents PARB on OCCY's Board of Commissioners. He also reported that her term is set to expire and that three names need to be submitted to the Governor for consideration. It was stated that Dr. Kerth's name can be resubmitted for consideration for another term.

Lou Truitt-Flanagan motioned and Melanie Johnson seconded to resubmit Dr. Kalie Kerth's name for consideration by the Governor to continue representing PARB on OCCY's Board of Commissioners. The majority of members present voted in the affirmative with two members abstaining. Motion passed.

It came to the attention of Chairperson Delaney that two more names will need to be submitted to the Governor and asked for nominations.

Dr. Kalie Kerth motioned and the Honorable Leah Edwards seconded to submit Sarah Herrian and Lou Truitt-Flanagan's names for consideration by the Governor to represent PARB on OCCY's Board of Commissioners. The majority of members present voted in the affirmative with two members abstaining. Motion passed.

7. PARB Database and Evaluation

Lisa White, OU's E-Team, provided an overview of the new PARB database. Some of the features will include:

- Member information and active status
- Add/modify case reviews
- Collect data from reviews
- Compile data from the case reviews into printable reports for the courts

Keith and Lisa reported that adjustments will be made as needs arise.

Lisa also provided an overview of the evaluation results of Oklahoma and Garfield Counties' PARBs. Some of the comparative results include:

- 278 forms completed for Garfield County, 274 forms for Oklahoma County
- Garfield County reviewed 133 cases, Oklahoma County reviewed 210 cases
- 250 children in Garfield County were impacted by the reviews, 377 children in Oklahoma were impacted
- 28 children with Tribal affiliation in Garfield County, 79 children in Oklahoma County
- The largest age group impacted in both counties are from age 0-3 years
- Placement was the most used recommendation category in both counties

Handouts of the presentations were provided.

8. PARB Program Manager's Report

Keith reported that new badges will be created for PARB members. The new badges will have expiration dates will coincide with the end dates of the members' terms. He also reported on the progress of the three special projects for which he has been working: Eliminating jury trials during parental termination hearings, children at risk of abuse or neglect due to community isolations, and conducting a summit that focuses on permanency.

9. Review of the Local PARB Board Recommendations and Development of Annual State PARB Recommendations

Discussion and Possible Action

Keith reported on the results of the local PARB annual reports for calendar year 2020. Keith requested to receive recommendations from the Board members. Some of the Board recommendations include:

- Focusing on permanency and its barriers.
- Focus on legislative issues that PARB could positively impact.

Lou Truitt-Flanagan motion and Melanie Johnson seconded to accept the Board recommendations as written. The majority of members present voted in the affirmative except for David Ross, Lisa Buck, and the Honorable Leah Edwards who were absent during the vote. Motion passed.

State Level Activities

- 1. The PARB annual report was finalized and submitted to the Commissioners by the May 1 deadline. The Commissioners asked that the State PARB Board spend more time clarifying and researching the recommendations and to resubmit them. The 2020 PARB Annual Report is part of the State PARB meeting packet.
- 2. The OU E-Team reports have been finalized. These reports include the combined Oklahoma and Garfield County Report and the PARB Membership Report. Final edits are being made to the PARB database. The database will go live on August 24th when a virtual training will take place for all PARB members. After that, PARB staff will work individually with communities to help them successfully use the database.
- 3. New PARB badges will be made after the State PARB Meeting for any State PARB Members that are interested in getting one.
