

2024 Impact Report





The first full year of the Legacy Capital Financing Fund (the "LCFF") ushered in a new era of capital project funding for the State of Oklahoma. This self-financing structure has and will save hundreds of millions of dollars on interest expense and cost of issuance fees, while streamlining the process of funding projects.

In 2023, along with the signing of the Legacy Capital Financing Act, the first ten projects were authorized and \$600 million was appropriated. In 2024, an additional \$177 million was appropriated (SB1125), bringing the total funds to \$777 million. Seven more projects were authorized as part of the 2024 legislative session; two each for OU and OSU, headquarter updates for OSBI, additional funding for the DPS training facility, and the State Capitol Arch.

Since inception, the corpus of the LCFF has been invested by the State Treasurer's Office. To date, the LCFF has earned an incredible \$27 million in interest. These dollars will remain unallocated until assigned to projects via the legislative process. Between the unallocated appropriated dollars, recapitalization payments, and interest earnings, the LCFF had approximately \$98 million available for future projects at the end of calendar year 2024, with the total growing monthly.

I would like to extend my thanks to the State Treasurer and his staff for continuing to champion our work and the administration of the LCF. The splendid investment returns on the LCFF are the result of seamless teamwork across divisions, led by Treasurer Russ.






As of 12/31/2024






