1. Call to order, certification of Open Meeting Act compliance, and establishment of a quorum by roll call. [Chair, Governor Stitt]

2. Review, discussion, and possible action to approve the minutes of the June 27, 2024, meeting. [Chair, Governor Stitt]

5. Status update on the execution of Memoranda of Understanding ("MOUs") between OCIA and state agencies for authorized Legacy Capital Financing Act ("LCFA") projects, in accordance with 73 O.S., §§ 187A through 187B. [Jamie Manoles]

Director Manoles reported the update on the recently signed memorandum of understanding for the Legacy Capital Financing Fund which included OSUVMA vet school project, DPS for Phase 2 of their training Center, OMES for the Capitol Arch, and OSBI for their headquarters projects.

6. Discussion and possible action to approve the MOU between the Oklahoma Office of Management and Enterprise Services ("OMES"), the Oklahoma Department of Libraries ("ODL"), and OCIA for the LCFA project established by 73 O.S., § 187A-6. This MOU includes revisions from the standard agreement approved by the Authority on August 10, 2023 ("Template MOU"), consisting of: 1) language that reflects OMES' statutory obligation to administer the funds "for the benefit of" ODL; and 2) other non-substantive changes. Bd. of Regents of Oklahoma Colleges, 1997 OK 21, 934 P.2d 335); 2) language limiting venue to Oklahoma County District Court; and 3) other non-substantive changes. [Maria Maule]
