## **ASAM Quick Reference**

The American Society of Addiction Medicine (ASAM) criteria is an evidence-based template to determine the appropriate level of substance use disorder intervention for an individual. The Oklahoma Department of Mental Health and Substance Abuse Services (ODMHSAS) mandates contracted treatment agencies to utilize this criteria in determining appropriate level of substance use disorder treatment (level of care). Providing too low or too high levels of care will both likely result in poor outcomes and waste available treatment resources.

Research indicates that substance use disorder treatment services should be at least 90 days in duration and be based on assessed need (NIDA). Treatment duration includes changes from one level of care to another (ex. a combination of residential and outpatient services of at least 90 days). For the highest likelihood of beneficial treatment outcomes, there should be a seamless transition of services when transitioning between levels of care as treatment needs change.

ASAM criteria uses six dimensions to provide a holistic assessment of the individual.

## **ASAM Six Dimensions**

**Dimension 1: Acute Intoxication and/or Withdrawal Potential** 

Past and current experiences of substance use and withdrawal.

**<u>Dimension 2</u>**: Biomedical Conditions and Complications

Physical health history and current condition

<u>Dimension 3</u>: Emotional, Behavioral, or Cognitive Conditions and Complications

Thoughts, emotions, mental health needs, and behavioral health history

**Dimension 4: Readiness to Change** 

Readiness and interest in changing

Dimension 5: Relapse, Continued Use, or Continued Problem Potential

Likelihood of relapse or continued use or continued behavioral health problems

**Dimension 6: Recovery and Living Environment** 

Relationship between recovery and living environment (people, places, and things)

The status of these six dimensions, as assessed by a trained clinician, will provide recommendations on the most appropriate treatment options.
