Ms. Knoblock stated that the Trust wants to move to empower ODMHSAS staff to negotiate with Cleveland County to sell the land to Cleveland County Health Department that its building sits on; as well as enter and negotiate with Cleveland County to sell the land that Cleveland County Health Department currently sits on for no less than \$137,000 an acre, which is the current appraised value per acre on the total parcel. She stated that before issuing to enter into any agreement, the sale need to have final approval of the land trust.

Ms. Stomprud moved to go forward with Cleveland County negotiations, for no less than \$137,000 an acre. Dr. Ali seconded the motion.

DISCUSSION AND POSSIBLE ACTION RE: POSSIBLE SITE FOR NEW CRISIS CENTER AT 13TH STREET AND LOTTIE, OKLAHOMA CITY

Dr. Crosby opened about the negotiations with the city of Oklahoma City. As part of their most recent maps project, he stated ODMHSAS is wanting to build a new crisis center. He asked for permission to enter negotiations to build that center on the property located at the corner of 13th and Lottie in Oklahoma City.

Ms. Knoblock requested a motion to pursue transferring the land at Northeastern 13th Street and Lottie to the city for the purpose of constructing a new crisis hospital which would be operated by ODMHSAS. She confirmed with Dr. Crosby that he will bring that back to the Land Trust once it is negotiated.

Once the negotiations have been completed, before entering into a final agreement, the trust will reconvene, Dr. Crosby added.

Ms. Stomprud moved to approve the motion to proceed with 13th Street and Lottie negotiations. Ms. Holland seconded the motion.

Dr. Crosby asked the Trust to approve putting the Norman land out for bid, so ODMHSAS can sell the land for proceeds to go towards the new hospital.

Ms. Knoblock elaborated that the motion is to move forward with the remaining land in Norman where Griffin Memorial Hospital currently sits and put it on the market with a commercial agent for purchase.

Once the negotiations have been completed, before entering into a final agreement, the Trust will reconvene, Dr. Crosby added.
