## 27. Engineering Contracts

a) Osage County - Commission District VIII (E.C. 881)

The Department has selected The Benham Companies, Inc., of Tulsa to prepare complete final environmental documents and engineering studies for US-60 from Pawhuska east to Bartlesville in Osage County. The consultant will also be responsible for alignment studies, preliminary survey and right-of-way documents. Total engineering fees are $\$ 293,000.00$. Funding will be $80 \%$ federal funds and $20 \%$ soft match credit.
b) Washington, Nowata and Craig Counties - Commission District VIII (E.C.882)

The Department has selected Craig \& Keithline, Inc., of Tulsa to prepare complete final environmental documents and engineering studies for US-60 from US-75 east to Vinita, encompassing W ashington, Nowata and Craig Counties. The consultant will also be responsible for alignment studies, preliminary survey and
right-of-way documents. Total engineering fees are $\$ 449,275.00$. Funding will be $80 \%$ federal funds and 20\% soft match credit.

Note: Mr. Streb pointed out to the Commission that in the text on Item 27.b) the dollar amounts for Environmental Studies and Alignment Studies were reversed. The amounts should be as follows: Environmental Studies $\$ 345,900$ and Alignment Studies $\$ 81,250.00$.

## a) Rogers County - Commission District VIII (E.C. 119G Supplement No. 1)

The Transportation Commission previously authorized Alexander Engineering Company, Inc., to prepare final design plans for $\mathrm{SH}-88$ between the Town of Inola and City of Claremore. This supplement is for the revision of existing bridge plans and will involve widening of existing bridge structures. Adjusted engineering fees are $\$ 22,000.00$, which brings the total engineering contract cost, including supplementals, to $\$ 726,300.00$. The first phase of construction is in the 8 Year Construction W ork Plan in FFY 2005. Funding will be 80\% federal funds and $20 \%$ soft match credit.
b) Rogers County - Commission District VIII (E.C. 120G Supplement No. 2

The Transportation Commission previously authorized Guy Engineering Services, Inc., to prepare final design plans for $\mathrm{SH}-88$ between the Town of Inola and the City of Claremore. This supplemental agreement is for additional survey, roadway and bridge work. The additional work will involve grade, drain, structural design and hydraulics. Adjusted engineering fees are $\$ 86,300.00$, which brings the total engineering contract cost, including supplementals, to $\$ 492,300.00$. The first phase of construction is in the 8 Year Construction W ork Plan in FFY 2007. Funding will be with $80 \%$ federal funds and $20 \%$ soft match credit.
