30. 2009 Standard Specifications

Presentation of the 2009 Standard Specifications for Highway Construction

Mr. Schmitt explained that the Specification Book provides the minimum acceptable standards for highway construction. The book is periodically updated to incorporate new pay items, make corrections, etc. Mr. Schmitt introduced Mr. Anthony Delce who is our Department Specifications Engineer. Mr. Delce oversaw the effort of updating the Specifications Book. Mr. Delce said in the beginning five subcommittees were organized consisting of approximately fifty people who were involved in this project. ODOT personnel as well as Federal Highway Administration, Association of General Contractors, Oklahoma Asphalt Pavement Association and American Concrete Pavement Association personnel served on these subcommittees. Trotter Consultants was charged with technical writing and quality control. Mr. Delce stated that we anticipate having these specifications incorporated in time for the June 2010 letting. He also thanked everyone who participated in this effort.

PRESENTED BY THE SECRETARY/DIRECTOR - Mr. Ridley

31. Director's Report

Secretary Ridley said Anthony Delce had shoulder-length hair when he started the Standard Specifications project. He further complimented Anthony on a job well done, and stated that he is an asset to our organization.

Mr. Gary Evans provided an up date on the ARRA funds. We have \$439 million obligated, which is 99.4% of available funds. Sixty-four (64) projects have been completed with ARRA funds, representing \$85 million worth of work. Contractors have been paid \$240 million for ARRA projects, which is just under 52% of the funds. Further, we have to have all ARRA funds obligated by March 1, 2010.

Oklahoma submitted a \$1.95 million application for federal funding for high-speed rail to improve the rail line from the Red River north to Oklahoma City and on to Tulsa. Funding in the amount of \$8 billion was available for high-speed rail projects. Unfortunately, Oklahoma was not included in the distribution of these funds.

Secretary Ridley complimented our maintenance workers on a job well done. He pointed out that we do not have the manpower to work 'shifts' and that our personnel work until their job is done. Chairman Overland questioned levels of our salt stockpiles. Gary Evans stated that we normally keep 60,000 tons of salt on hand at the beginning of winter. This year we stockpiled an additional 30,000 tons at the Port of Catoosa. With this stockpile we are, in essence, full and ready for the remainder of the winter season.
