88. Engineering Contracts
a) Statewide - County Maintenance Site Adaptation Program (EC-1286)

Cobb Engineering Company has been selected to produce site adaptation plans for future maintenance yards. The total, not to exceed, for these services is $\$ 916,000.00$. This contract will be funded with $100 \%$ state funds.
b) Statewide - All Districts - Aerial Photography (EC-1296)

The Department has selected HMG and Aerial Data Service to perform aerial photography services statewide. The aggregate total for these contracts will not exceed $\$ 500,000.00$.

Funding for these contracts will be 80\% federal funds and 20\% soft match credit.
c) Statewide - All Districts - LiDAR Mapping (EC-1297)

Bearing Tree Land Surveying has been selected to perform survey-grade mapping. The aggregate total for these contracts will not exceed $\$ 250,000.00$. Funding for these contracts will be $80 \%$ federal funds and $20 \%$ soft match credit.
d) Statewide - All Districts - Pre-Construction Surveying and Mapping (EC-1298)

89. Engineering Contract Supplements
a) Statewide - All Districts - Statewide Intermodal Transportation Plan (EC-1209, Supplemental No. 2)

Parsons Brinckerhoff, Inc. (PB Americas) was previously authorized to develop the 2010-2035 Statewide Intermodal Transportation Plan. This supplemental agreement is for a Statewide Transit System Overview and Gap Analysis needed to help identify existing transit services and major initiatives underway that will likely impact the future of passenger travel options in Oklahoma. The total, not to exceed, amount of this agreement is $\$ 114,904.00$. The total engineering contract cost, including supplements, is $\$ 1,398,397.00$. This contract supplement will be funded with $80 \%$ federal funds and $20 \%$ soft match credit.
b) Sequoyah County - Commission District I (EC-1207B, Supplemental No. 2)
C. H. Guernsey \& Company was previously authorized to perform design services for Port of Entry facilities on I-40 in Sequoyah County. This supplement is for additional geotechnical investigation. The total, not to exceed, amount of this supplement is $\$ 5,000.00$. The total engineering contract cost, including supplements, is $\$ 425,523.00$. This contract supplement will be funded with $80 \%$ federal funds and $20 \%$ soft match credit.
c) Pittsburg County - Commission District II (EC-529, Supplemental No. 5)

Craig \& Keithline, Inc., was previously authorized to prepare environmental documents and functional plans for the US-69 corridor from the new Comanche Interchange north of McAlester to the Indian Nation Turnpike. This supplement is necessary to provide design and modified construction plans for the US-69/Hereford Lane Interchange. The total, not to exceed, amount of this supplement is $\$ 94,700.00$. The total engineering contract, including supplements, is $\$ 2,860,200.00$. This contract supplement will be funded with $80 \%$ federal funds and $20 \%$ soft match credit.
