## 159. Director's Report

Secretary Ridley showed a presentation with photos of the bridge at Bird Creek needing emergency repairs. He stated that the bridge, which has historical significance since it is on the original SH-66 and is one of the original bridges on US-66, has had over 40 emergency repairs in the last three years.

Secretary Ridley stated that approximately 530 bridges have been rehabilitated over the last 5 years. Another bridge in the work program is on I-244 across the Arkansas River. We received Tiger funds for this project, and it should be on a letting after the first of the year. He thanked Ivan Marrero, FHWA, for working with us to ensure the project is authorized and approved by the end of the year. Secretary Ridley stated our current SAFETEA-LU continuing resolution/extension goes through the end of the month. He does not think we will receive a new re-authorization bill before that time, but we will hopefully receive an extension that goes through the end of the federal fiscal year.
