17. Engineering Contracts

a) Sequoyah County – District I (EC-1308)

The Department has selected Cabbiness Engineering to perform preliminary engineering and to prepare final construction plans for US-64 over Big Sallisaw Creek. The total, not to exceed, amount is \$540,000.00 and will be funded with 80% Federal and 20% Soft Match Credit. This project is included in the 8 Year Construction Work Plan with a scheduled let date in FFY 2013. The total estimate for construction contract for this project is \$5,445,898.00.

b) McCurtain County – District II (EC-1309)

The Department has selected EST, Inc. to perform preliminary engineering and to prepare final construction plans for US-70 from approximately 0.2 miles west of the Choctaw/McCurtain County Line extending east approximately 2.6 miles. The total, not to exceed, amount is \$422,000.00 and will be funded with 80% Federal and 20% Soft Match Credit. This project is included in the 8 Year Construction Work Plan with a scheduled let date in FFY 2015.

c) McCurtain County – District II (EC-1310)

The Department has selected EST, Inc. to perform preliminary engineering and environmental document for US-259 from the Texas State Line extending north to the Idabel Bypass. The total, not to exceed, amount is \$529,600.00 and will be funded with 80% Federal and 20% Soft Match Credit. This project is included in the 8 Year Construction Work Plan with a scheduled let date in FFY 2017.

d) McCurtain County – District II (EC-1329)

The Department has selected BWR Corporation to perform preliminary engineering and to prepare final construction plans for SH-3 from 5.09 miles west of Broken Bow east 5.09 miles. The total, not to exceed, amount is \$1,075,100.00 and will be funded with 80% Federal and 20% Soft Match

Credit. This project is included in the 8 Year Construction Work Plan with a scheduled let date in FFY 2018.

e) Garvin County – District III (EC-1331)

The Department has selected Cobb Engineering Company to perform preliminary engineering and to prepare final construction plans for SH-76 from SH-19 north 8 miles into McClain County. The total, not to exceed, amount is \$814,400.00 and will be funded with 80% Federal and 20% Soft Match Credit. This project is included in the 8 Year Construction Work Plan with a scheduled let date in FFY 2015. The total estimate for construction contract for this project is \$17,268,700.00.

f) Dewey County – District V (EC-1332)

The Department has selected two engineering firms to perform preliminary engineering and to prepare final construction plans. The following firms were selected:

This contract will be funded with 80% Federal and 20% Soft Match Credit, and the project is included in the 8 Year Construction Work Plan with a scheduled let date in FFY 2012. The total estimate for construction contract for this project is \$6,424,151.00.

g) Major County – District VI (EC-1334)

The Department has selected MacArthur Associated Consultants, LLC to perform preliminary engineering and to prepare final construction plans for US-412 from approximately 10 miles east of Mooreland east 4.1 miles, and for SH-15/US-412 from the Woodward County Line extending east 2.04 miles. The total, not to exceed, amount is \$541,000.00 and will be funded with 80% Federal and 20% Soft Match Credit. This project is included in the 8 Year Construction Work Plan with a scheduled let date in FFY 2013. The total estimate for construction contract for this project is \$13,200,644.00.

24. Addition to the Industrial Access Road Program

Muskogee County – District I – The Muskogee City-County Port Authority has requested participation by the Department in an industrial access project that supports the many industries located at the Port of Muskogee. The Department, the Muskogee City-County Port Authority and the Oklahoma Turnpike Authority will enter into a three party agreement to facilitate the project. The estimated cost of the project is \$2,455,607.00. The Muskogee City-County Port Authority has committed \$600,000.00 to the project. The Turnpike Authority will be responsible for the initiation, construction, and completion of all work associated with the project. The Department's participation will include only the surfacing costs for East Harris Road and both of ODOT's southbound ramps for the Hyde Park Bridge and shall not exceed \$600,000.00.

25. Director's Report

Mr. Evans provided the Director's Report.

Mr. Evans provided an update on the snow and ice removal from last week's winter storm. In addition to ODOTs work crews, 27 private contractors assisted with the removal. Mr. Evans also commended ODOT employees Kimberly Kutz, Division VI, and Kenny Carlisle, Division V, Clinton Residency. Both employees worked to clear the roadway in their own Divisions and then worked additional shifts in Oklahoma City and/or Tulsa areas.

Mr. Evans stated that the snow storm cost will be between \$4-6 million to ODOT. We used approximately 25,000 tons of salt and 40,000 tons of sand. Equipment has been maintained and stockpiled salt has been moved around the state from the Port of Catoosa in preparation for the next winter storm this week.

Mr. Evans recognized the Field Maintenance Engineers who direct the storm response on a day to day basis and also the teams that they represent.
