Tim Gatz introduced Gayle Ward the Executive Director of the Association of County Commissioners of Oklahoma (ACCO). Ms. Ward gave a brief summary of the approved 20125 -Year CIRB Program. It has a total of 471 Projects, out of these, 414 will be to replace bridges and to reconstruct 686 miles of roads. It will cost approximately $\$ 705,000,000.00$ and $\$ 583,000,000.00$ will come from CIRB funds, the remaining funds will come
from City, Federal and Tribal monies. She thanked the Commissioners and ODOT for their efforts in helping counties all over the State of Oklahoma improve their roads and bridges. She stated it will not just only improve the safety of the traveling public, but will help improve our economy.

## 93. Director's Report

Secretary Ridley cautioned us to be aware that we have enough 2011 federal funds available for federal projects through October, 2011. However, do not plan any federally funded projects in November until we know how much federal money we will be receiving from Washington D.C. He said that the debates are still on-going in Washington D.C for the SAFETEA-LU Reauthorization Bill and hopes to know an exact amount we will be receiving within the next few weeks.

Secretary Ridley advised that the Department has been in discussion with the Turnpike Authority about providing us a reliever route between the Chickasaw Turnpike and US 177 around the Sulphur area. This interchange is much needed because of the traffic congestion on SH 7 due to the amount of rock trucks in the area. The discussion is that the Department will provide ingress and egress where the Chickasaw Turnpike hits US 177. If the Turnpike Authority approves this, then we would go into an agreement that the Department would build the 2 ramps, and then bring it back to the Commission for approval. If approved we would then take over the maintenance responsibility of that 4 mile section between SH 7 and US 177. It would provide a lot of relief to the traffic congestion problems in this area.
