The fiber optic that is being installed within ODOT's Right-of-Ways will be in support of state government facilities, Higher Education, Vo-Techs, and other types of facilities like that. In addition, there will be some additional capacity within that structure that can serve the private sector and those will be done under agreements with other third party telecommunication providers. So basically the intent of the fiber optic system is to increase the internet access and bandwidth capabilities in rural locations of the state.

## 70. Addition to the Industrial Access Road Program

Commission District V - Beckham County
The City of Sayre is requesting approval for an industrial access project for the Sayre Business Park. The new investment by the City and the industries locating in the park will exceed $\$ 2,800,000$, which will create over 200 new full-time jobs. The estimated cost of the project is $\$ 800,000$ and the Department's participation shall not exceed $\$ 465,000$.

We only get two and a half million dollars a year and we want to leverage that money to the fullest.

## 71. Emergency Bridge Repair Project

Craig County - District VIII - Bridge on SH-10 over Big Creek West of Welch.
NOTE: Mr. Ridley read the Emergency Declaration Journal Entry No. 71 to the Commission. He asked that Casey Shell come and brief everyone on the status of this emergency repair and how ODOT employees worked to keep the public safe during the heavy rainfall in northeastern, Oklahoma. Mr. Shell stated that on May 1, 2012 parts of northeastern Oklahoma received 7-8 inches of rain in a short period of time which caused a lot of flooding. Our normal practice is when we are expecting heavy rains the county superintendents are out running their routes checking on the normal trouble spots and looking for any new ones. He praised the actions of Craig County Superintendent, Gayland Wooten who discovered the damage of the SH-10 bridge as he was out driving his route. As Mr. Wooten was crossing Big Creek Bridge on SH10 he felt a dip at the end of the bridge and stopped to investigate. Moments later, flood waters washed out the abutment and Mr. Wooten quickly closed the bridge. "Thankfully, our folks are experienced and they know what to do," Mr. Shell said. "He potentially saved somebody's life." State Highway 10 over Big Creek was reopened on Friday, May 4, after emergency repairs were made to the bridge. Mr. Shell noted that this bridge is in the 8 Year Program and is scheduled to be replaced in 2016.

NOTE: Commissioner Love suggested that the Department needs to commend Mr. Wooten for doing a great job, and definitely need to let the Legislature know about how ODOT prevented someone from losing their life.

## 68. Director's Report

Mr. Ridley introduced special guests; Keili McEwen, from Governor Mary Fallin's office and Gayle Ward, Executive Director of ACCO (Association of County Commissioners of Oklahoma).

Mr. Ridley addressed transportation funding proposals currently being considered by the state legislature. He stated that he is grateful for support from many house and senate members, and is hopeful that transportation funding will be fully restored after three years of reduction to ODOT's share of motor fuel tax collections. "We hope that it will be reestablished, so there is not a continuation of the diversion of gas and diesel taxes away from transportation," Ridley said, "That will affect our eight year program, so it is important for us to have that baseline funding."

Mr. Ridley stated that we were honored to have Congressmen Bill Shuster, Congressman James Lankford, and Congressman John Sullivan who came to town and visited with us. The Congressmen, Governor Fallin, Chairman Love, and I went downtown to look at the deconstruction of the I-40 Crosstown Bridge and looked at the beams as they were coming off the bridge. The plans are to reuse those beams to repair about 350 county bridges, which Governor Fallin addressed in her bridge plan to reduce the amount of structurally deficient bridges in Oklahoma.

Mr. Ridley reported on the opening of the first of nine new state-of-the-art weigh and inspection stations. He said that the new station on I-35 in Kay County is 90 percent operational and that a second facility on I-40 in Beckham County should be completed in about three months. One of the nine locations will be a virtual system where it will be unmanned; the other locations will have people at them, along with Department of Public Safety and Corporation Commission staff. These facilities will serve as ports of entry to the state, which will ensure that trucks entering the state meet size and weight regulations.

NOTE: Commissioner Love asked how some Ports of Entry would work if they were "unmanned". Mr. Ridley explained the virtual site would include technologies such as, weigh-in-motion (WIM) devices, Automatic License Plate Readers, and cameras, to capture a record of trucks that are not in compliance with State Laws. Notifications will then be sent to OCC and DPS.

NOTE: Commissioner Alexander asked if you pass an "unmanned station", and already have an overweight permit will the OCC and DPS be notified, or will it recognize the permit. Mr. Ridley explained when the full technology is implemented the system will screen trucks and recognize the overweight permit and allow them to pass without incident.
