Mr. Streb stated, "Yes, much greater, usually a couple of hundred thousand pounds". The studies on these type of loads are quite a science; so when DPS gets a request for these types of heavy loads they send them directly to this Consultant. The Consultant will then perform a study to provide a safe route for them to move this large of load through our state safely.

## 83. Addition to the Industrial Access Road Program

## a) Commission District VIII – Tulsa County

The City of Sapulpa and the Tulsa County Commissioners are requesting approval for an industrial access project for Helmerich & Payne. Helmerich & Payne is investing \$20,000,000 to expand their facility and will create 80 new full-time jobs. The total cost of the project is estimated at \$340,000.00 and the Department's participation shall not exceed **\$200,000.00** 

#### b) Commission District VII - Comanche County

The City of Lawton and the Comanche County Commissioners are requesting approval for an industrial access project for Goodyear Tire & Rubber. Goodyear is investing more than \$150,000,000 to expand their facility and creating hundreds of new jobs. Goodyear will have spent over \$850,000,000 in the facility and will employ 2500 people.

The proposed project will have two (2) phases. Phase 1 begins east of 112<sup>th</sup>, on Lee Boulevard and extends west approximately .30 miles, then turns north on 112<sup>th</sup> and extends approximately .90 miles to

the railroad tracks. The City and the County will be responsible for the initiation, construction and completion of all work associated with the project. The estimated cost of Phase 1 of the project is \$2,700,800.00. The Department's participation for Phase 1 shall not exceed **\$950,000.00**.

**NOTE:** Commissioner Love asked who follows up to ensure that these companies are using our funds appropriately. Mr. Surrett replied we don't do specific follow up on jobs, but we do follow up on the construction project. However, we don't proceed with the construction project until the expansion is taking place.

Commissioner Love asked who determines the exact cost of the project and how much ODOT's participation is. Mr. Surrett replied that it is done by the City or the County, whoever the sponsoring entity is.

Commissioner Burgess stated that the Goodyear facility has added on a whole new wing totaling \$150 million dollars. We did a plant tour about a month ago and they are creating several new jobs to facilitate that expansion. So they have already started the expansion and this is a great project for Lawton, these are high paying jobs starting at \$30,000 dollars a year plus benefits. This is a great company and if you're ever down that way take some time to tour this great facility.

Commissioner Regan stated that Helmerich & Payne is a great company and he toured the facility 2 weeks ago. This company has also begun their expansion, they are estimating 80 something new jobs, but may get up to as many as 125 new jobs. These jobs start out at approximately \$60,000 dollars a year. Commissioner Regan said he has no problem with investing money to help this great company.

Commission District VI - Texas County

The City of Guymon is requesting approval for an industrial access project for SPF – North America. SPF is investing approximately \$10,000,000.00 in a new facility in the Guymon Industrial Park and is creating approximately 40 new full-time jobs.

The modified proposed project begins at 24<sup>th</sup> Street on Cactus Drive and extends north approximately 0.80 miles, then west on Road T approximately .50 miles to Hurliman Road. The City will be responsible for the initiation, construction and completion of all work associated with the project. The estimated cost of the project is \$1,600,000.00. The Department's participation in the project shall not exceed \$475,000.00.

NOTE: Mr. Surrett explained the only change is that we went to the west instead of the east to provide the access road. It was recommended by the City and it just made good sense, other than that, no other changes were made.

## 87. Director's Report

Mr. Ridley introduced 2 special guests, Former Senator, Ed Fisher, and Former Secretary of Transportation, Phil Tomlinson.

Mr. Ridley stated it was a good day, as most of you know we attended a special ceremony at the State Capitol prior this meeting and witnessed Governor Fallin sign HB 2248 and HB 2249. He thanked the state leaders for making transportation funding a priority and supporting the governor's initiative. He stated, "Members and leadership of the legislature in the House and Senate, regardless of party, wanted to come together and develop a plan so they can say that we accomplished something by the end of this decade". "We have an end-game for a problem that has plagued our state for decades". Now that we have the funds available to fix these problems, which began back in 2006 with the Webber Falls Bridge incident, it will just take time to complete them all. He stated that it took 14-15 years to build the interstate, and it will take about that long to complete these projects.

Mr. Ridley presented Deputy Director/Chief Financial Officer, Mike Patterson with the pen that was used by Governor Fallin to sign HB 2248 and HB 2249. He praised Mr. Patterson for his work with the legislators, committees, and individual members to make sure they knew and fully understood how the funds would be spent.

Mr. Patterson thanked Mr. Ridley for the pen, and said he wouldn't be able to do his job, if it wasn't for all the great ODOT staff that helps him do his job sufficiently.
