# MINUTES FOR THE TRANSPORTATION COMMISSION MEETING HELD IN THE ODOT BUILDING COMMISSION MEETING ROOM OKLAHOMA CITY, OKLAHOMA

## AWARDS AND PRESENTATIONS PRESENTED BY COMMISSION CHAIRMAN

Commissioner Love called upon Secretary Ridley who stated he had some announcements to make and some special guests to introduce. Mr. Ridley recognized Gary Evans, Assistant Deputy Director/Chief Engineer who would present the Icon Award.

Mr. Evans stated that the Oklahoma Department of Transportation was recently honored with the Icon Award from Intergraph for OkiePROS (Permitting Routing Optimization System). Intergraph is a subsidiary of Hexagon, a multinational company that produces Intelligent Mapping Geographical Information Systems
software. This award is given to Intergraph partners that demonstrate the best use and implementation of its products. He stated that the new Electronic Permit Routing System was created by team members from Oklahoma Department of Transportation and Oklahoma Department of Public Safety. This is a great new system that allows trucks with oversized and overweight loads that meet certain criteria to be automatically approved and issued a permit over the internet in less than 10 minutes, a process that previously took 2 to 3 days. Mr. Evans presented the Icon Award to Jay Adams who accepted the award for the team members.
Mr. Ridley announced the retirement of Joe Kyle, the Rail Programs Division Manager. He recognized David Streb, Director of Engineering to come and say a few words on behalf of Mr. Kyle.

Mr. Streb said Mr. Kyle has been the only Rail Division Manager at ODOT, so it will be hard to move forward without him since he has been the only who has done this job. Mr. Kyle has been with ODOT for 42 years, he started part-time in the late 1960's, but came on full-time in 1970. He has done a phenomenal job for ODOT; he was very instrumental in bringing passenger rail back to Oklahoma in 1999 and also in the Rail Crossing Program, which has eliminated a lot of fatalities at our railroad and highway crossings. Mr. Kyle was presented a Governor's Commendation for his 42 years of service and a State flag in a case that was flown over the State Capitol during the month of May.

Mr. Ridley informed the Commission that we lost another ODOT family member in a tragic accident while working in a construction zone on I-40 down by Henryetta. Tim Vandiver was the Superintendent at the Checotah Maintenance Yard and had been with ODOT for 25 years. He and his family (brother and uncle) have a combined total of 90 years of service of working for ODOT. Mr. Ridley asked that a moment of silence be held in his memory and pray in your own way for his family, friends, and co-workers.

Mr. Ridley introduced special guest, Senator Bryce Marlatt, Chairman of the Senate Appropriations Subcommittee on Transportation. Another special guest was Congressman James Lankford, who sits on the House Transportation and Infrastructure Committee and was a House conferee involved in negotiation of House Resolution 4348, which was approved by Congress on Friday, June 29. Mr. Ridley asked Congressman Lankford to give a report on the recently passed highway funding bill.

Mr. Lankford was very pleased that the surface transportation bill passed with strong bipartisan support and contained no earmarks. He explained that H.R. 4348 provides two years of transportation funding and contains key reforms that will give states more control over how funds are spent. The final version of the bill included a reform requested by Lankford that gives states more flexibility in how they categorize and use transportation enhancement funds.

Mr. Lankford said that Congress also worked to streamline the permitting process and lift restrictions on environmental review for projects with no significant impact to the environment, allowing construction to begin much quicker. "There were no real deadlines and we wanted to get hard deadlines in place," Lankford said. "This takes us from a seven-year period that was typical for major projects to a maximum length of four years."

The Congressman explained that a major negotiation point was his call to move more authority from the federal government to state transportation agencies. "People in many other states don't trust their Department of Transportation like we trust ours, so they want to keep control in Washington, D.C." Mr. Lankford said. "My statement over and over again was, 'Don't punish us in Oklahoma because you don't have a DOT like we have. You go get one like we have."'
