Commissioner Love called upon Secretary Ridley who presented a slide show of deteriorating bridges, due to delayed maintenance, caused by years of underfunding for state highways and bridges. However, thanks to the Governor's and State Legislature's commitment to funding transportation we will be able to address the State's remaining known structurally deficient bridges by the end of the decade. Mr. Ridley told the Commission that the presentation showed only a little part of what's included in the 8-Year Work Plan; and hoped it helped them understand the critical need of all the projects in the 8-Year Work plan.

Mr. Evans wanted to point out that Ray Sanders and his Project Management staff deserves a big thank you, as they play a pivotal part of the process. They receive all the information and put work plans together for all 8 Districts; and with a budget of 5.6 Billion Dollars that is a lot of projects. Last of all, he thanked in advance the Consulting Engineering Team, the Contracting Team, and the Material Suppliers, as they stand with us and make it possible to execute these plans.

134. Director's Report

Mr. Ridley thanked the Commissioners for their time and participation in helping us prepare the 8-Year Work Plan, meetings with Governor Fallin and the legislature.

Mr. Ridley pointed out that the current and upcoming improvements to the State's transportation system would not have been possible without the additional funding provided by the State's lawmakers.

"During this past session, the legislature worked with Governor Fallin on her plan to increase our funding incrementally over the next few years and provide us enough money in the next 7 or 8 years to be able to fund the other 167 structurally deficient bridges that we did not have a funding solution source for, a year ago," Ridley said.

Due to the increased funding proposed by Governor Fallin's Bridge Improvement and Turnpike Modernization Plan, this will ensure that the number of known structurally deficient bridges on highways will be essentially eliminated by the end of the decade.

Mr. Ridley asked Senator Bryce Marlatt, Chairman of the Senate Appropriations Subcommittee on Transportation to come and say a few words, since he was one of the key components in getting us this extra funding.

Senator Marlatt thanked the Commissioners, Mr. Ridley and all ODOT staff for all their hard work. He stated that he has worked with a lot of Agency Directors and any time you confront them about certain issues they immediately become combative and start protecting their territory; but that's not the case with Mr. Ridley. He said Mr. Ridley was always willing to meet with them and discuss issues, and was open to any suggestions of how they could lower overhead cost and put more money into laying pavement and into our roads. He said the Committee loves to work with directors like Mr. Ridley. Senator Marlatt said he is very pleased with the work ODOT has done over the past years by cutting in half the amount of structurally deficient bridges, and for educating the legislature and the public of the importance in assessing these needs.

NOTE: Commissioner Love asked what the average life span for a bridge is. Mr. Ridley deferred the question to Chief Engineer, Gary Evans.

Mr. Evans stated that when he thinks of the life span of a bridge, he thinks of 2 different aspects for that life span; 1) is its structural life span and 2) its functionality over time. He stated I believe what you're referring to is its structural life span, and with our technology that we have today and the way we construct bridges we hope to get somewhere around 70-75 years of life out of our bridges. What I mean about functionality is that it's 2012 now, but in 75 years what will transportation be like? The way I think about it is still a little bit of mystery to

me, will we still be with vehicles that travel on roadways and bridges, we probably will; but just as we seen transportation devices change over the last 75 years and getting larger, we assume that there will be significant changes over the next 75 years. I think we are prepared structurally, as to what the future will bring us as far as transportation vehicles; your guess is as good as mine.
