State ownership of rail line transfers to Union Pacific after 30-Year-Lease-Purchase Agreement

Commissioner Love called upon Secretary of Transportation, Mr. Gary Ridley for announcements and presentations. Mr. Ridley stated that this is really a great day for ODOT and asked, Director of Engineering, Mr. David Streb to come and explain why this presentation is such a great day for ODOT and others.

Mr. Streb stated that 30 years ago our ODOT forefathers put together a plan to preserve a rail corridor. He commented that many times we question plans done by our forefathers, but today, I can say that I am honored to be a part of this plan which proved to be a good one for ODOT and the Railroad. Mr. Streb asked Acting Rail Division Manager, Mr. John Dougherty to come explain the plan and make the presentation.

Mr. Dougherty stated that 30 years ago ODOT purchased a rail corridor following the bankruptcy of Chicago, Rock Island and Pacific Railroad Company in 1982. ODOT's purchase of the railroad preserved the crucial rail corridor that links Enid, El Reno, Oklahoma City, Chickasha, Duncan and Lawton until it could be returned to the private sector. Union Pacific recently paid its final installment on the \$35 million owed for the rail line. He introduced the following employees of the Union Pacific Railroad in Omaha, Nebraska: Mr. Tony Love, Assistant Vice-President of Real Estate, Mr. Mark Mendenhall, Manager of Real Estate and Clint Schelbitzki, Director of Public Affairs. He also introduced 2 former ODOT Rail Employees who were involved in the lease-purchase agreement 30 years ago, Max Carter of Edmond and Joe Kyle, recently retired Rail Division Manager. Mr. Dougherty asked Mr. Ridley and Tony Love to come and sign the Agreement finalizing the transfer of 351 miles of rail line to Union Pacific.

Mr. Tony Love stated, "We really appreciate the State of Oklahoma and the Department of Transportation for having the foresight to preserve these lines." He added that, without the partnership with ODOT, replicating the same rail corridor today would be very difficult for his company. As a token of his appreciation he presented, Mr. Ridley a "Union Pacific Partnership Coin".
