## Award presentation from the Oklahoma Floodplain Managers Association (OFMA)

Commissioner Love called upon Secretary of Transportation, Mr. Gary Ridley for announcements and presentations.

Mr. Ridley recognized ODOT Employee, Leslie Lewis and Gavin Brady from the Oklahoma Floodplain Managers Association's. Ms. Lewis and Gavin Brady presented the organization's annual "Public Official of the Year" award to Transportation Secretary Gary Ridley for the Oklahoma Department of Transportation's cooperative effort with the City of Tulsa to construct the Perryman Ditch along I-44 in Tulsa. Completed in August 2010, the $\$ 42$ million structure greatly improved drainage in a flood-prone area of Tulsa by redirecting storm water to the Arkansas River. Each year, OFMA recognizes one floodplain administrator and one public official for public policy initiatives that address floodplain management needs for Oklahoma communities. Mr. Brady said, "Prior to the Perryman Ditch project, flooding in this area was frequent and costly, and by rerouting the flow and containing it within the culvert along the interstate right-of-way, the storm water relief line significantly improved the Tulsa flood hazard area for 1,264 homes that were removed from the floodplain." Special recognition was also given to Chief Engineer, Gary Evans and Randle White, Division 8 Engineer for their involvement in this project.

Mr. Ridley in his acceptance speech said, "The award really belongs to ODOT and the City of Tulsa, and we think of City of Tulsa Engineering Director Paul Zachary as a great friend of ours, and the cooperative effort we have with the City of Tulsa is second to none."

Mr. Ridley recognized 2 special guests, Victor Bird, Director of Oklahoma Aeronautics, and Shawn Rose from Governor Fallin's Office.

## 178. Director's Report

Mr. Ridley talked about how the mild weather conditions are allowing a lot of projects to continue without interruption. We have 2 large lettings coming up in January and February, which is absolutely the perfect time to let construction projects and not have any lag time.

Mr. Ridley stated that for the first time in Oklahoma, crews will use accelerated bridge construction techniques to assemble the majority of a bridge alongside its final location, and then move the structure into place. This project is the SH-51 bridge over Cottonwood Creek near Mannford in Creek County. We are really excited to see how this works out and will report back to the Commission when it's completed.

NOTE: Commissioner Love asked what the benefit of building an off-site bridge is.
Mr. Ridley explained that this will result in a road closure of less than 21 days versus an expected 6 month impact to traffic using conventional bridge construction methods.

Commissioner Love asked what the cost difference would be.
Mr. Ridley said he knows this particular bridge project has a higher initial cost than standard bridge construction, the anticipated user cost of a road closure required by standard construction far outweighs the user costs for the accelerated project. He didn't know the exact costs, but said he would get the numbers for them and report back to them as soon as he could

Commissioner Overland asked if this type of bridge could be built only in certain locations.
Mr. Ridley said this type of accelerated bridge construction does require that the site meet certain criteria.
