## 87. Addition to the Industrial Access Road Program Commission District VII - Stephens County

The Duncan Area Economic Development Foundation (DAEDF) is requesting approval for an industrial access road for Halliburton. Halliburton is investing more than $\$ 15,000,000$ to expand its facility and is creating 175 new full time jobs.

## 88. Correction to the Industrial Access Road Program

## Commission District VIII - Tulsa County

Agenda Item 83(a), which was approved at the June 4, 2012 Transportation Commission Meeting, had a $\$ 35,000$ error in the participation calculations. Item 83(a) should have read as follows:

The City of Sapulpa and the Tulsa County Commissioners are requesting approval for an industrial access project for Helmerich \& Payne. Helmerich \& Payne is investing $\$ 20,000,000$ to expand their facility and will create 80 new full-time jobs.

The proposed project begins at Southwest Boulevard on 49th West Avenue and extends northwesterly for approximately 600 feet, then turns northeasterly and proceeds parallel to the BNSF railroad for approximately 2400 feet, then north for approximately 500 feet. The City and the County will be responsible for the initiation, construction and completion of all work associated with the project. The estimated cost of the project is $\$ 340,000$. The Department's participation shall not exceed \$235,000

## a) Commission District I-McIntosh County

The McIntosh County Commissioners are requesting approval for a Lake Access Project for Lake Eufaula. The project will improve access to the public use facilities.

The proposed project begins at SH-9, on EW-121 and extends east approximately 0.35 miles to Dabbs Road, then proceeds north approximately 0.95 miles to the lake. The County will be responsible for the initiation, construction and completion of all work associated with the project. The Department's participation in the project shall not exceed $\mathbf{\$ 2 3 5 , 0 0 0} \mathbf{0 0}$.

## b) Commission District V - Washita County

The Washita County Commissioners are requesting approval for a Lake Access Project for Crowder Lake. The project will improve access to the public use facilities.

The proposed project begins at $\mathrm{SH}-54$, on $\mathrm{EW}-110$ and extends east approximately 2.0 miles to NS-241, then proceeds south approximately 1.0 miles to the lake. The County will be responsible for the initiation, construction and completion of all work associated with the project. The Department's participation in the project shall not exceed \$290,000.00.
c) Commission District III - Pottawatomie County

The City of McLoud is requesting approval for a Lake Access Project for the Wes Watkins Reservoir. The project will improve access to the public use facilities.

The proposed project begins at Redskin Road, on Arena Road and extends south approximately 0.75 miles to the entrance of the North Deer Creek Recreational Area. The City will be responsible for the initiation, construction and completion of all work associated with the project. The Department's participation in the project shall not exceed $\mathbf{\$ 1 0 0 , 0 0 0} \mathbf{0 0}$.

## d) Commission District II - Marshall County

The Marshall County Commissioners are requesting approval for a Lake Access Project for Lake Texoma. The project will improve access to the public use facilities.

The proposed project begins at Enos Road, on Kaney Road and extends west approximately 1.0 miles to Post Office Road, then proceeds south approximately 1.0 miles to Williams Farm Road, then west approximately 1.0 miles to the lake. The County will be responsible for the initiation, construction and completion of all work associated with the project. The Department's participation in the project shall not exceed $\mathbf{\$ 2 7 5 , 0 0 0} \mathbf{0 0}$.

## e) Commission District IV - Noble County

The Noble County Commissioners are requesting approval for a Lake Access Project for Lake Perry. The project will improve access to the public use facilities.

The proposed project begins at US-77, on NS-318 and extends south approximately 2.0 miles to the lake. The County will be responsible for the initiation, construction and completion of all work associated with the project. The Department's participation in the project shall not exceed \$120,000.00.

## f) Commission District VII - Jefferson County

The Jefferson County Commissioners are requesting approval for a Lake Access Project for Waurika Lake. The project will improve access to the public use facilities.

The proposed project begins at $\mathrm{SH}-5$, on Advent Road and extends north approximately 3.0 miles to EW-190. The County will be responsible for the initiation, construction and completion of all work associated with the project. The Department's participation in the project shall not exceed \$450,000.00.

## ITEM PRESENTED BY THE DIRECTOR - Mr. Patterson

## 93. Director's Report

Director, Mr. Patterson stated that we have been extremely busy, due to the extreme weather around the State. He provided details on the tornadoes and heavy rains that closed several interstates and highways for short periods of time. The May 20 tornado caused heavy damage to the old truss bridge on US-62 near Newcastle, moved part of it on to l-44 causing it to be closed temporarily. Flooding on May 31 caused damage to US-62 (N.E. $23^{\text {rd }}$ Street) near Midwest City, which has been narrowed from five lanes to two lanes while repairs are made.

Mr. Patterson stated he was very pleased with the agency's quick response to the destructive storms. "I have never been more proud of the ODOT family and how the agency responded to these events," Patterson said. "We made the call to mobilize ODOT workers and equipment at midnight and trucks were rolling in at 2 a.m."

Mr. Patterson called upon Director of Operations, Casey Shell to come and give a detailed report about what all ODOT did to help out storm victims and help with debris removal.

Mr. Shell praised the efforts of ODOT maintenance crews who came from all eight field divisions to clear storm debris from highways and local roads following the tornadoes that struck the Carney, Moore and Shawnee areas on May 19 and 20. We supplied relief for about 12 days following the storm events. We had a total of 830 employees who came to help with the relief efforts. He said, "Many of these workers missed out on Memorial Day weekend activities like graduation ceremonies, memorial services and family reunions to assist in Moore and south Oklahoma City; and the work was performed without any complaints, serious injuries or incidents." We had 400 pieces of equipment on site, spent a little over a million dollars and still counting in costs. We are hoping these costs are reimbursable by FEMA, and we are coordinating with them to try and get that money back to the agency.

Mr. Patterson noted that besides ODOT, there was 3 other agencies helping, Oklahoma Turnpike Authority, Department of Agriculture and the Soil Conservation Commission.

Mr. Patterson announced that the legislative session has ended. We are very pleased with our budget and are very appreciative of our Legislature and Governor.

Mr. Patterson announced that the flooding on May 31 has caused an emergency situation at US-62 (N.E. $23{ }^{\text {rd }}$ Street) near Air Depot. The roadway has washed away and there is a drop off of about 15 feet deep, and for the safety of the public we have to get this repaired as quickly as possible. The emergency is in excess of my authority, so I have to have Commission approval to get the roadway rehabilitation started. So we are going to have an emergency meeting immediately after this regular meeting is adjourned.
