Mr. Shell also extended a big thanks to Kevin Lowe and the video people who put the video together for him. He also wanted to recognize Kevin Bloss, Stephanie Richardson and Jennifer Mason from Division 9 who worked behind the scenes to make sure that our workers were fed, stayed hydrated and had a place to stay.

Mr. Love introduced Secretary of Transportation, Gary Ridley who wanted to say a few words about the tornado recovery effort.

Mr. Ridley stated that after a disaster there is always a lag time of approximately 2 weeks or more before FEMA can get contracts done with cleanup crews; and our Governor, Mary Fallin didn't want that lag time. Mr. Patterson, Mr. Shell, Mr. Bloss and I met that Monday evening following the tornado and came up with a plan to help with the cleanup efforts. Within 24 hours our people were down in Moore and lined up to start helping with the cleanup. The cleanup effort was amazing by ODOT and OTA, we were hugged by the citizens of Moore, who expressed their thanks and were really appreciative for our help.

Mr. Ridley complimented Roy Counts of Division 3 for his daily coordination of the cleanup efforts. He also thanked Casey Shell for all his hard work; and who moved his family up here for the weekend to a motel so he could be close to them and still assist in the cleanup efforts.

Mr. Ridley stated that since the Governor couldn't attend this meeting today she has asked him to thank all the State Employees for making Oklahoma look good in this crisis.

## 106. Director's Report

Director, Mike Patterson stated we have recognized the 800 and some employees that were out helping with the cleanup. Now I want to recognize the employees that were back at the divisions doing their work and covering the work load of people that were out and helping in the disaster cleanup. He stated that he was very appreciative and humbled by the efforts of this entire agency to keep things going while we were responding to a huge emergency situation.

Mr. Patterson addressed the recent Annual Bridge Report released from the Federal Highway Administration detailing the nation's structurally deficient bridges. He stated he was happy to report that for the first time in his recollection, the state highway system in Oklahoma is actually pulling the percentage down. When we started our endeavor back in 2005 and 2006 there were 1168 structurally deficient bridges, we were at $17 \%$ of our 6800 bridges, so we were pulling the average up. Now that we are down to 556 structurally deficient bridges on a 6800 bridge system we are now at $8 \%$. In comparing that to the national average of $11 \%$ our highway system is now pulling the average down. Mr. Patterson said, "Our gratitude goes to the Legislature and the Governor for putting a plan together to move us toward our ultimate goal of getting that number less than $1 \%$ by the end of the decade." He also commended the ODOT family for their hard work and being laser focused on helping get those number of SD bridges down to a manageable condition on the state highway system.

Mr. Patterson apologized to the Commission for the appearance of our roadsides, because our grass is too high. As stated earlier in the Commission Meeting we have been extremely busy with the disaster cleanup and we missed our first mowing. Now that the cleanup is done, our crews can get back to taking care of our highways and right of ways.

Mr. Patterson thanked the Commissioners for staying late for last month's emergency meeting, so that we could address the emergency project on US-62, commonly referred to as N.E. $23{ }^{\text {rd }}$ Street here in Oklahoma City. That project has been completed by Haskell Lemon Construction.

In closing Mr. Patterson announced that next month's Commission Meeting will be moved to Monday, August $12^{\text {th }}$ at 11:00 a.m. We have to change the meeting date of August $5^{\text {th }}$, since the majority of the senior staff will be attending a Highway Transportation Conference in San Francisco, California.

NOTE: Commissioner Love asked how much the emergency project ended up costing. Mr. Patterson answered \$865,000.
