## 148. Presentation of the proposed CIRB 5 Year County Work Program

The Department has worked with the County Circuit Engineering Districts from across the State to compile an update to the 5 Year CIRB plan.
The plan has been prepared to reflect increased funding levels approved by the State Legislature through HB 2249. Funding for the CIRB program is currently derived from $18 \%$ of the revenues accruing from the Motor Vehicle and Registration Act. HB 2249 will increase these funding levels to 20\% beginning in State Fiscal Year 2015.
The Plan was developed with consideration for the critical needs of the County Transportation System within the financial constraints of funding projected to be available to the program.

## 149. Director's Report

Mr. Patterson thanked the Commissioners for approving the 8 Year Work Plan, the Asset Preservation Plan and the CIRB Program. He stated that all these will have a huge impact on our transportation network over the next several years. He expressed his appreciation for the time they spent visiting with them so we could get their input on the 8 year plan. He thanked everyone who worked on all these things behind the scenes; Ray Sanders and his employees, Division Engineers, Shannon Sheffert and his staff, Circuit Engineering Districts and County Commissioners. He said it takes a team effort to plan all this and he appreciated every ones time and hard work. He commented that with all these programs together, all of the state's remaining structurally deficient highway bridges are scheduled for replacement or major rehabilitation by 2020. ODOT's and Governor Fallin's goal has been to get the State's structurally deficient bridge down to less than $1 \%$ by 2020. In our focus to achieve this goal our highway pavement system has suffered. He stated, "With this 8 year plan, we're beginning to address our highway pavement problems, it doesn't cover all the projects we need to do or want to do, but it certainly includes everything we can do with the resources we have."

Mr. Patterson said one of the challenges that we have in fulfilling these projects is federal funding. As of right now we are still waiting to hear from Washington on how much funding we will receive. As many know the government is on shutdown, hopefully this will end soon, I will keep you updated.

Secretary Ridley thanked everyone who was involved in the 8 Year Work Plan, Asset Preservation Plan and CIRB Program. It is a lot of work to make sure that the critical needs of the State are being met; and he said the Governor is very pleased with the way ODOT conducts business with these programs.
