## 177. Director's Report

Director Patterson commended the ODOT employees for their hard work and long hours they put in during the last snow/ice storm. He said they did a great job in trying to keep the roads clear, but sometimes it's hard to stay ahead of Mother Nature.

He commented that two of the contracts that the Commission had just approved, is for the third Port of entry weigh and inspection station being built on I-40 in Sequoyah County near the Arkansas border. The previous two that were built was in Beckham County and Kay County.

Director Patterson updated the commission on the agency's plans for future construction projects, considering the low balance in the federal government's Highway Trust Fund, which provides reimbursement to states for highway construction projects. With federal reimbursement in jeopardy, ODOT could be forced to delay engineering and construction projects in the 2014-2021 Eight-year Construction Work Plan. He stated, "In the coming weeks, ODOT will be making a plan for how to handle our bid lettings in 2014. It would not be prudent to continue to put projects on the street if the Highway Trust Fund's cash balance doesn't improve. We're hopeful that Congress will step in with a solution that will provide the necessary cash in the federal Highway Trust Fund to support the federal transportation authorization, MAP-21, and allow us to continue our Eight-year Construction Work Plan."

Director Patterson informed the commissioners that the 3 brochures they had at their desk, is information that he hands out to everyone when he speaks at a public events/meetings. The brochures are: 1) Fiscal \& Organizations Strategy; 2) Update on Oklahoma Bridges and Highways; and 3) Waterways.

He briefed commissioners on ODOT's support of the McClellan-Kerr Arkansas River Navigation System in eastern Oklahoma, a 445 mile freight corridor that includes the state's two public ports, the Port of Catoosa and Port of Muskogee. These ports are a connector route to the Mississippi River and help move goods and other resources through our state. Since 2000, we have invested $\$ 417$ million in highway and bridge improvements within 10 miles of the Port of Catoosa and nearly $\$ 66$ million within 10 miles of the Port of Muskogee. In the 2014-2021 Construction Work Plan we have an additional $\$ 200$ million in projects for the Port of Catoosa, and an additional $\$ 55$ million in projects for the Port of Muskogee. He stated that he just wanted the commissioners to have this more detailed information about ODOT.

He updated the commissioners on two of ODOT's significant projects; he stated that we are always being asked when these projects will be completed. The first one is in Tulsa County, I-44, Riverside to Yale; it should be completed in Fall 2014. This total project is costing us around $\$ 400$ million. The second one is in Oklahoma County I-235, Broadway Extension and I-44; we are only on the first segment of this very complex project. However, we are 2 months ahead of schedule, but it will still be a while before we complete this project. Each intersection at this area carries around 200,000 vehicles a day; and it makes it very difficult to complete it quickly when you are trying to work around that much traffic.

NOTE: Commissioner Burrage asked if any of the projects they approved today, or any of the projects in the past few months would be in danger of not being done due to lack of funding.

Director Patterson responded that once a project is awarded, we are going to do everything in our power to complete those projects. We know that one of the hardest things to do is to shut down an on-going project. Do we have enough cash, that is one thing we are going to sit down and look at, and I will be able to advise you better on this at the next commission meeting.

Commissioner Burgess complimented the Department on the additional information that they provided this year. Over the years it has gotten better and better; and this information today is excellent.
