## 101. Director's Report

Director Patterson reported that last month on June 13, 2014 we opened the Purcell/Lexington Bridge. We had a celebration hosted by the Chamber of Commerce and the Governor was in attendance. Mr. Patterson stated through an ODOT subsidy, a shuttle service was provided free of charge to the citizens of these communities, and during the 4 month bridge closure we had approximately 11,000 riders. He introduced Steve Lalli, Oklahoma Transit Association Executive Director and Jeannie McMillian, Oklahoma Transit Association President. Mr. Patterson stated, "We at ODOT really appreciate the State's Public Transit Providers for mobilizing quickly with a solution for the detour; and I heard over and over from the people of Purcell and Lexington that the shuttle service and the bus drivers really helped to make the situation more tolerable".

Mr. Patterson updated the Commission about the Sale of the Sooner Sub Rail Line. He said that John Bowman and his staff have been working on the Final Sale Agreement and we should close the deal next month. He said we have been asked many times what are we planning on spending the $\$ 75$ Million Dollars that we profited off of this sale. We still own many miles of rail lines that we lease out to Short Line Operators, we will make the much needed improvements and repairs to those tracks. We have a problem with safety across the state with our Rail Road crossings; we will spend a great amount of this money to upgrade these track crossings, such as gate arms, flashing signals and full-depth crossing surfaces. This is something that we have to do because the moving of freight through this state by rail has increased significantly; and it's important that we protect the traveling public and provide them with a safe effective transportation system.

Mr. Patterson commented on a letter that we had received from U.S. Secretary of Transportation, Anthony Foxx talking about the reimbursement issues of federal funds. He said this letter is about the Highway Trust Fund approaching insolvency. Mr. Patterson also gave the Commission a copy of a letter he wrote to Senator, James Inhofe in Washington, D.C. outlining what our challenges would be here at ODOT if this should happen. He stated that though the Department remains hopeful that Congress will take action to preserve funding, it is possible that federal reimbursement to ODOT and other states for current transportation projects could be reduced beginning in August. Without federal funding, ODOT will postpone bid lettings for future highway and bridge projects.

NOTE: Commissioner Love asked if the proceeds of the Sooner Sub Sale, can those funds only be designated for rail repairs or rail matters.

Director Patterson said yes that is correct, because any proceeds that we receive from rail sales or from rail leases, has to go into a Railroad Maintenance Revolving Fund. This fund is set up specifically to maintain our state-owned rail lines, do safety improvements on railroad tracks that cross our roads, highways and streets.

Commissioner Love asked what the balance of this Rail Fund is before the $\$ 75$ Million gets deposited.

Russell Hulin, Chief Financial Officer said the balance is approximately \$4 Million.
Commissioner Alexander asked if it was by statute that these funds have to be spent on rail issues.

Director Patterson stated that was correct.
