## ITEM PRESENTED BY THE DIRECTOR - Mr. Patterson

## 115. Director's Report

Director Patterson briefed the Commissioners on the details of the Sooner Sub rail line, which will be finalized following the Commission Meeting. He explained this is the rail line that runs between Sapulpa and Midwest City, and the Commission back in May, approved to sale to Stillwater Central Railroad a WATCO Company, for $\$ 75$ Million. Proceeds from this sale will go to an ODOT fund designated for improvements to state-owned rail line, included safety upgrades at rail crossings.

Director Patterson told the Commissioners that the Chickasaw Nation has offered to partner with ODOT to take another look at issues expressed by the public about a future bridge project near Tishomingo in Johnston County that is scheduled in Federal Fiscal Year 2018. Through this partnership, ODOT is evaluating possibly replacing the structurally deficient SH-99/US-377 bridge over the Washita River with a new bridge built on an offset alignment. This partnership would look at solutions to allow the existing bridge to remain open to traffic without a detour during construction.

Director Patterson gave an update on legislation recently passed by Congress to maintain the solvency of the Highway Trust Fund, ensuring continued federal funding for hundreds of ongoing and planned transportation projects in Oklahoma. He explained that that the $\$ 10.8$ billion measure will extend funding through May, 2015, but that a permanent solution is needed to provide the certainty required for long-term transportation planning. Director Patterson said, "This measure helps solve two short-term issues by allowing ODOT to move forward with new highway and bridge projects as scheduled, and ensuring timely payments can be made to construction contractors for ongoing work". What the DOT's would like to see is a 6 year bill (MAP 21 was a 2 year bill), the 6 year bill would better fit the way DOT's do business. So we will continue our conversations with our Congressional Delegation, which are in complete support of our transportation infrastructure, not only in this state, but in the country. Our Delegation understands what it takes to have a viable economy and to provide safety to the traveling public and they're very supportive of a long term measure.

Director Patterson updated the Commissioners on the emergency project they awarded at last month's Commission Meeting; which was referred to as the "Slide Project" in Division 2 on US-271 in Pushmataha County near Clayton. Because of the 70 mile highway detour for drivers we expedited the bidding process procedure and awarded an emergency contract with strong financial incentives for early completion. The contractor originally bid 40 days to reopen the highway, but worked around the clock and reopened the highway in 18 days. Director Patterson presented a slideshow of this project from start to finish. He stated that the Division II Engineer, Anthony Echelle would be at the podium at the end of the slideshow if the Commissioners had any questions.

NOTE: The Commissioners has no questions, but Commissioners Love and Burrage both commended Anthony Echelle and his employees on a job well done.
