## 127. 8-Year Construction Work Plan

The Department has completed the proposed 8-Year Construction Work Plan with consideration for the critical needs of Oklahoma's transportation infrastructure and the financial constraint mandated by the projected Federal and State funding availability. The Work Plan is balanced by the District within the budgetary limitations of Federal fiscal years 2015 through 2022. The encompassed projects have been defined, validated, and included in accordance with the transportation needs and priorities of the State.

NOTE: Commissioner Overland wanted to make sure that the Reconstruction of the Lexington/Purcell Bridge had been moved up to be included in this 8 Year Work Plan, and wanted to know a completion date.

Mr. Sanders answered, "Yes, it is included in this 8 Year Work Plan; I will have to get back with you on the estimated completion date.

Director Patterson thanked Commissioner Overland for that question. He said the bridge is to be let in 2018 with an estimated 18 months to complete. He pointed out that the Lexington/Purcell Bridge is now open, but load posted at 36 tons so just certain types of trucks can pass over it. We are putting together another public meeting in conjunction with Representative, Bobby Cleveland and Representative, Lisa Billy; so we can update the citizens in that area and let them know the progress of where we are at in terms of getting the new bridge completed.

Commissioner Love asked when the 8 Year Work Plan would be available for the public to view.

Director Patterson said over the next few days we will be delivering copies to the Governor, the House and Senate Members, and it will be out on our website by tomorrow for the public to be able to go online and view.

## 129. Director's Report

Director Patterson stated that this past month has been difficult on the ODOT family. We have attended way too many funerals. Mr. Patterson asked for a moment of silence in remembrance of the following people:

Becky Saliba, the wife of Darren Saliba;
Jeanette James, the wife of Charlie James;
Jack Schmiedel, was our Assistant Bridge Engineer
Bill Hamilton, was an Inspector at our McAlester Residency
Director Patterson recognized, Bob Rusch, Bridge Engineer. He said that Mr. Rusch will be retiring at the end of September after many years. He thanked him for his great leadership, years of hard work, and dedicated service to this agency. Mr. Patterson invited Secretary Ridley to say a few words about Mr. Rusch.

Secretary Ridley stated that ever since the bridge was knocked down on I-40 about 12 years ago, he has seen Mr. Rusch and his division do some great work; and it can be contributed to great leadership by Mr. Bob Rusch. He said Mr. Rush taught him a lot as an engineer and thanked him from the bottom of his heart for all his work over the years and that he will be sorely missed.

Director Patterson talked about the 8 Year Plan highlights include:
935 Bridge Projects (with only 468 of them being structurally deficient)
1,947 Total Projects
743 miles of shoulders and other improvements to 2-lane highways
725 miles of major improvements to high-volume highways and interstates
Totals 6.3 billion in improvements
Director Patterson talked about the 4 Year Asset Preservation Plan that is also updated each year. The plan was created 6 or 7 years ago and was designed to extend the life cycle of highways and bridges through timely preventative maintenance, including resurfacing and rehabilitation projects. He stated, "With the continued support of state leaders and the public, ODOT is moving closer to the point where we can address bridges through preservation, rather than reconstruction; and it is much more cost-effective to invest in preservation of our highways and bridges now, than it is to completely rebuild them earlier than planned".

Director Patterson congratulated the Agency for putting together another 2 great Plans; he said it involves a lot of time and work. He also thanked the Commissioners for taking time out of their busy schedules to meet with them and for their input into the plans. He just wanted to let everyone know that he really appreciates all their hard work.

Director Patterson recapped the recent announcement by Governor, Mary Fallin and transportation officials of a $\$ 100$ million ODOT initiative to improve safety warning signs at rail crossings statewide. This is a huge deal for this agency; this is going to add a program that will accelerate many of the safety components that would otherwise take us 10 to 12 years to get to, we will be able to get it done in 3 to 4 years. The agency is currently identifying rail crossings for improvement, and plans to have a complete list of projects finalized early next year.

Director Patterson invited everyone to a Ribbon Cutting of the I-244/Arkansas River Bridge Project in Tulsa on Monday, September, $15^{\text {th }}$ at 10:00 a.m. ODOT and the Tulsa Regional Chamber will be hosting this event, and special guests planning to attend are Governor, Mary Fallin and U.S. Deputy Secretary of Transportation, Victor Mendez.

NOTE: Secretary Ridley commented that this coming October, marks 3 years that Governor Fallin had announced that her goal was that by the end of the decade to get the State's SD Bridges down to less than 1\%. Can you tell us where are we at on achieving this goal for our Governor.

Director Patterson answered that ODOT is continuing the decade-long effort to reduce the number of structurally deficient bridges. At the end of December 2013 our total Structurally Deficient Bridge count was at 468 of 6800 bridges, and our goal is to get to 68 . That is $1 \%$ or less of the 6800 bridges. So we are right on goal to achieving our commitment to Governor Fallin.
