## 155. Presentation of the proposed CIRB 5 Year County Work Program

The Department has worked with the County Circuit Engineering Districts from across the State to compile an update to the 5 Year CIRB plan.

The plan has been prepared to reflect increased funding levels approved by the State Legislature through HB 2249. Funding for the CIRB program is currently derived from $18 \%$ of the revenues accruing from the Motor Vehicle and Registration Act. HB 2249 will increase these funding levels to 20\% beginning in State Fiscal Year 2016.

The Plan was developed with consideration for the critical needs of the County Transportation System within the financial constraints of funding projected to be available to the program.

Mr. Sheffert said the highlights of the CIRB Plan to improve the county road system include:

- Nearly $\$ 985$ million in improvements
- Replacement or rehabilitation of 541 county bridges
- 69 bridges incorporating recycled I-40 Crosstown bridge beams
- Improvements to 1,050 miles of county roads

Mr. Sheffert introduced special guest Randy Robinson, Transportation Engineer from the Association of County Commissioners of Oklahoma (ACCO). He said Mr. Robinson wanted to talk a little bit about the CIRB Program too.

Mr. Robinson handed out a copy of their Quarterly Newsletter. He pointed on that on Page 11 of the "Newsletter" it shows some completed projects, with pictures and total construction costs. He explained that these are just some of the projects that could not be achieved if it wasn't for the CIRB Program. He thanked the Commissioners and ODOT for making this CIRB Plan continue from year to year.

## ITEM PRESENTED BY THE DIRECTOR - Mr. Patterson

## 156. Director's Report

Director Patterson talked about the CIRB Program. He said that it is a really good program that was created by the State Legislature in 2006; and it is state money that is designated strictly for county bridges and county roads. The CIRB Program combines federal transportation funds and state motor vehicle revenue with local resources, allowing counties to undertake major projects that they couldn't complete on their own.

Director Patterson showed a video of the SH-51 Bridge Slide Project in Creek County. He had talked about this new experimental bridge construction method at last month's Commission Meeting. Director Patterson reminded everyone that typically the bridge would have been closed and traffic detoured for 120 days; however, this project only closed the bridge for 10 days, which impacted the traveling so much less. He congratulated everyone involved with this project for a job well done!

NOTE: Commissioner Love asked if this type of construction cost more than a normal bridge project would.

Mr. Patterson answered, "That is correct, I'm not sure how much that is; even though it cost the agency more, it greatly reduced the amount of cost to the traveling public".

Commissioner Love asked other than costs, why can't we do this type of construction more often.

Mr. Patterson answered, "There are limiting factors, primarily the size of the bridge." "We have learned a lot from that State of Utah who has done this more; so we are looking for more opportunities now that we have actually done one".

Commissioner Love asked if we could do some number crunching and let the Commissioners know at the next Commission Meeting how much more this type of construction cost the agency.

Mr. Patterson answered, "Yes, that they would work on that and present that to them".
Director Patterson told Commissioners that due to a federal mandate, ODOT has recently tested and is preparing to display real-time traffic information on highway message boards in the state's metro areas. The agency plans to implement the system in the Oklahoma City metro area beginning the week of November $10^{\text {th }}$ and in the Tulsa area early next year. Director Patterson said, "This is a great tool that will help drivers understand how traffic is moving up ahead and plan their routes accordingly during the morning and evening rush hours". The message boards will broadcast estimated travel times between major highway junctions from 6-9 a.m. and 3-6 p.m., Monday through Friday.

NOTE: Commissioner Overland asked if there would still be other alerts such as, "accident ahead" etc.

Mr. Patterson answered, "Yes, in the case of "Accident Ahead", "Silver Alert", "Amber Alert", "Emergency Weather Alerts", those kinds of alerts supersede the traffic information".

Director Patterson said last month we had a visit from some of the nation's top transportation officials. The first one was, Congressman, Bill Shuster who is the Chairman of the Transportation and Infrastructure Committee of the House of Representatives in Washington D.C. Chairman Shuster made stops in Muskogee, Tulsa and in Oklahoma City; we enjoyed visiting with him and look forward to working with him during the reauthorization period. The second person was U.S. Secretary of Transportation Anthony Foxx who made a stop in Tulsa to see firsthand Oklahoma's progress in improving transportation corridors. Secretary Foxx at a Round Table Event hosted by Senator James Inhofe's, joined other state transportation officials to discuss the state's long-term transportation development and remaining infrastructure needs. Director Patterson also thanked Commissioners, Burrage and Regan for participating in the Round Table event.

Director Patterson reminded everyone that the Commission next month has been changed to December 8, 2014.
