166. Director's Report

Director Patterson talked about the recent developments at the federal level as Congress moves closer to a long-term solution for transportation funding. On November 5th the U.S. House of Representatives approved the Surface Transportation Reauthorization and Reform Act, a 6-year federal transportation funding bill that will now go to a Conference Committee. He said they approved a 6-year plan, but only have enough money for 5 ½ years. So when they get together and make amendments it may just be a 5-year plan. He stated we have had no long term resolution since 2005, so hopefully we will get one this time. He expressed his thanks to members of Oklahoma's Congressional Delegation for their work on the legislation.

NOTE: Secretary Ridley commended Director Patterson for doing a great job in representing ODOT in Washington, DC.

Director Patterson introduced Harold Smart, General Manager of the ODOT Soccer Team, which won the Championship last month!

Director Patterson thanked the State Legislature and Governor, Mary Fallin for approving Trooper Nicholas Dees and Trooper Keith Burch Act, which bans texting and driving in Oklahoma. The law went into effect on November 1st and will help address distracted driving and protect highway workers, drivers, passengers, cyclists and pedestrians. He said that ODOT has had 59 employees and numerous contractors' employees have lost their lives due to inattentive driving. He stated, "There's not a single ODOT maintenance worker who hasn't had a close call working alongside highway traffic, so this law to provide additional safety is much appreciated".

NOTE: Commissioner Love asked what Legislator authorized the texting bill.

Director Patterson said the bill was authored by Representative, Terry O'Donnell and Senator, Ervin Yen.

Secretary Ridley talked about former Secretary, Phil Tomlinson and said he is fighting for his life, he's battling cancer. He asked that everyone please keep Secretary Tomlinson in their prayers.

Commissioner Burrage thanked Secretary Ridley for his work on the DRIVE Act and the assistance he gave Senator Inhofe by providing testimony and information and that goes for all the other ones in the Department that helped too. Your long term view of transportation both nationally and on a statewide and local basis has meant so much to our state. We see further evidence of that in the announcement of the turnpike package that you're leading as the Secretary of Transportation. He thanked him for his leadership and vision; it takes a lot of experience to know what, when and how and you have all that, and you figured it out. He stated that ODOT is involved in the turnpike events from the standpoint of coordinating our efforts, and your leadership there has meant so much to the Department. A lot of people don't recognize the fact that when we build a turnpike that the Department of Transportation gets to use that expenditure as soft match for our federal funds, and that will ensure that we will never not be able to fund a project, when there are funds available on the federal level. That is a big advantage in this state that other states don't have, and sometimes the public and others overlooks that, but that is a major leg-up for us. I am excited about it, and as the Chair I want to applaud your efforts on the DRIVE Act and the \$900 million dollar turnpike package that you introduced that's the Governor's initiative.
