# Sand Springs Residency receives 2015 Pharaoh Award for Innovative Accelerated Bridge Replacement Project for SH-51 over Cottonwood Creek

Director Patterson said he was proud to announce that the Association of General Contractor's honored an innovative ODOT project with the Pharaoh Award, which recognizes the best bridge construction in the State. The award recognized the replacement of the SH-51 Bridge over Cottonwood Creek near Mannford in Creek County. It was completed in late 2014 by using accelerated bridge construction techniques; which means ODOT's Contractor was able to construct the new bridge alongside the existing structure while the highway remained open to traffic. The old bridge was then removed and the new bridge was slid into place, resulting in a highway closure of only 11 days rather than the 6 months required using conventional construction methods. The Director showed a short video of this project from start to finish. Accepting the award for Division 8 was Division Engineer, Randle White and Commissioner, Pete Regan.

#### 181. Presentation of the proposed CIRB 5 Year County Work Program

The Department has worked with the County Circuit Engineering Districts from across the State to compile an update to the 5 Year CIRB plan.

Funding for the CIRB program is currently apportioned from revenues accruing from the Motor

Vehicle and Registration Act to be used for the construction or reconstruction of county roads or bridges that are of the highest priority.

The Plan was developed with consideration for the critical needs of the County Transportation System within the financial constraints of funding projected to be available to the program.

Mr. Sheffert said the highlights of the CIRB Plan to improve the county road system include:

- Nearly \$916 million in improvements
- Replacement or rehabilitation of 439 county bridges
- 52 bridges incorporating recycled I-40 Crosstown bridge beams
- Improvements to 875 miles of county roads

#### 182. Director's Report

Director Patterson stated that it is a great day for Transportation Departments all across the country. It is because of the much-anticipated passage of a long-term federal transportation bill. He said he was happy to report that Congress passed the Fixing America's Surface Transportation (FAST) Act; and it was signed into law by President Obama on December 4<sup>th</sup>. The FAST Act provides 5 years of federal funding and important policy reforms, which are crucial to ODOT's ability to deliver the projects in the 8-Year Construction Work Plan. We are pleased with how this turned out, and there has been discussion of how much money the Department will receive; we don't know yet, but we do know that every state will see an increase. Director Patterson thanked the members of Oklahoma's congressional delegation, especially Senator Inhofe's tireless efforts for getting another long-term fund passed. He noted that the last time the country seen a long-term fund passed was in 2005 and Senator Inhofe was the Chairman on that Committee also. He said Congressman Mark Wayne

Mullin from Oklahoma was a member of the Conference Committee that negotiated the final legislation. Two other people who have been battling for this a long time are Senator Lankford and Secretary Ridley. I know Gary has been laser focused on getting something done; because he's drug me up and down that hill we call Capitol Hill in Washington, DC many a times, and we stood in front of the desk of many members, both from this state and other states. I wish he was here so we could congratulate him, I did the other day, and I will again later this afternoon, but I think this is a real milestone for Gary as the Director and the Secretary of Transportation here in Oklahoma.

Director Patterson said he really appreciated the comments from the Commission for recognizing the effort it takes to put that CIRB plan together. It is, as Shannon articulated and you guys well know, it's a combination of a collaborative effort of the County Commissioners, of which there are 231, of the Circuit Engineering Districts, of which there are 8, and Shannon's staff. It takes a great deal of effort to make that happen; and I just want to congratulate Shannon and his staff for producing what I think is a great plan.

He congratulated the agency for their participation in a Bedlam fundraiser, and their willingness to help others in need. We raised in excess of \$2,000 so that we could fill out our angel tree and support ODOT families and others in the community that need help at Christmastime.

He informed the Commission that Bob Rose was attending his last Commission Meeting. He said Bob is retiring after 44 years of service. He has made a profound difference in many of us in the way we do our work. Bob has been the Division Engineer for 29 years; and I have never known another Division Engineer that has held that position for that long! He congratulated Bob and thanked him for all his years of service.

**NOTE:** Commissioner Burgess told Bob that it has been a privilege working with you. He stated, "I appreciate all the times you told me yes; and believe it or not, I appreciate all the times you told me no, because it turns out you were right". I appreciate your professionalism and how you carried yourself through our little endeavor. I can honestly say that your biggest concern has always been the traveling public, this agency and making sure that our tax dollars are well spent. You've been a good steward of those tax dollars, and I've really enjoyed working with you. I can't begin to explain how much I'm going to miss you

Commissioner Burrage said, "I think I was about 35 when I met Bob, so that was many, many, many, many years ago when I was a young commissioner". He told Bob that the credibility that he possessed is unlike a lot of people. Of all the things you've done, one thing that was always special to me is just the amount of credibility that you have and the leadership and guidance that you've given. So, what an asset you've been, and when you speak, people do listen and we have appreciated your time here.
