38. Director's Report

Director Patterson stated he only had 1 thing to talk about today and that was Item #41 that Chelley Hilmes presented to you. He said this item was done because we are reacting to the latest Revenue Failure declared last week by Secretary Doerflinger. This 2nd revenue failure amounts to about \$17.6 million dollars and coupled with the \$13.2 million back in December, does mean that we have taken a hit to our ROADS Fund of just over \$30 million dollars. As we move forward, we are not going to identify what projects will be impacted by this revenue shortfall, we will just wait to see if we can make it; I doubt it. We will just continue to let projects on our current pace, and at some point I'm sure there will be some projects this year that will be delayed, and more in upcoming years that will have to be delayed or postponed. That just goes to show that these types of revenue impacts do have an impact on what we do and how we deliver projects; and how we can affect Oklahoma and provide a safe transportation system to the state. So to wrap this up, there will be an impact, don't know where and to what extent, but there will be an impact
