Commissioner Burrage recognized Secretary Ridley who had an announcement.

## **ANNOUNCEMENTS AND PRESENTATIONS**

Secretary Ridley called for a moment of silence in memory of former Secretary of Transportation, Phil Tomlinson who passed away on March 29, 2016.

Commissioner Burrage then called on Director Patterson for his announcements.

Director Patterson kicked off a 2 month campaign focusing on safety in highway work zones with a proclamation from Gov. Mary Fallin declaring April and May "Work Zone Awareness Months" in Oklahoma. He also unveiled public service announcements expected to air on television and radio stations this spring and summer. The campaign includes profiles of ODOT workers, weekly Work Zone Wednesday reminders displayed on ODOT's highway message boards, a dedicated Facebook cause page and display of the

National Work Zone Memorial Wall at Penn Square Mall in Oklahoma City and Woodland Hills Mall in Tulsa in May, among other things.

He noted that, "Last year, 13 motorists were killed and 521 were injured in collisions inside highway work zones," Patterson said. "We must do better, but it will take the driving public partnering with us to make that happen."

#### 56. Director's Report

Director Patterson talked about the new Earthquake Protocol. The Oklahoma Department of Transportation is relieved by the results of a recent scientific analysis showing it's unlikely that a 4.6 or less magnitude earthquake will damage transportation infrastructure in the state, including bridges. Infrastructure Engineers Inc., a team of consultants that worked closely with researchers

from the University of Oklahoma, validated ODOT's inspection process. Additionally, the year-long study of earthquake data revealed there is no structural damage occurring on bridges after tremors below magnitude 4.7, indicating that bridge inspections are unnecessary below this level. The department will continue to inspect bridges after earthquakes, but starting at a threshold of 4.7 magnitude events.

"This is great news for Oklahomans concerned with the long-term effects of increased earthquakes in our state," said Mike Patterson, ODOT executive director. "Our department has aggressively inspected bridges and infrastructure for the past few years and learned a great deal through this process about this relatively new phenomenon in our state."

We have created a "Post-Earthquake Bridge Inspection Manual" that describes best practices in detail as well as providing a step-by-step inspection guide. At the request of Governor Fallin this comprehensive document will be used by all ODOT bridge inspectors statewide, and will be shared with other state agencies and government entities such as the Oklahoma National Guard and with counties and municipalities.

Director Patterson said we are excited to launch a two-month initiative to drive home the message that motorists are on the same team with ODOT in ensuring that everyone goes home safely each day from our work zones. The National Campaign is called, "Don't Be That Driver", ODOT's Campaign is called "First Line of Defense: Behind the Cones", and we're asking all ODOT employees and retirees to join us in spreading this important safety message. The 2016 campaign will feature:

- "Work Zone Wednesdays" featuring safety messages for the public each Wednesday on highway digital message signs
- A new Facebook page dedicated to work zone safety.
- "Work Zone Warriors" is a set of worker profiles from each division to be released on our Facebook page each week.
- ODOT will sponsor the first Work Zone Summit on April 6 for ODOT and its partners to brainstorm how to better coordinate work zones
- TV and radio Public Service Announcements (which was presented by a slideshow to the Commission)
- At next Commission Meeting which is on May 2 we encourage everyone to wear Orange
- The American Traffic Safety Services Association Foundation's National Work Zone Memorial Wall which has the names of all 59 ODOT employees killed in the line of duty will be displayed May 13-18 at Penn Square Mall in Oklahoma City and May 20-22 at Woodland Hills Mall in Tulsa. The memorial wall visit to Oklahoma is sponsored by Action Safety Supply Co.

He pointed out that ODOT has had more employees killed in the line of duty; that is more than any other state agency. In the last 5 years there have been 84 fatalities in work zone accidents. Thanks to all our workers who keep our highways safe. So please join us in supporting them in this year's work zone awareness campaign.

**NOTE:** Commissioner Love asked, "Have you ever found any bridge or road damage caused by an earthquake".

Director Patterson answered, "ODOT has never found any structural bridge damage in the state related to earthquakes since inspections began in 2013. Oklahoma's bridges meet federal design standards, meaning they are meant to safely withstand some degree of vibrations and movement.

Commissioner Alexander wanted to thank the Contractors who work in our Work Zones, for enforcing safety for their employees and ours. He also thanked the Media & Public Relation Division for putting a positive spin on this very sensitive subject.
