## PRESENTATION

Division 1 Sallisaw Residency receives 2016 Pharaoh Award for the construction of the new Combs Bridge Project in Cherokee County over Illinois River

Director Patterson said he was proud to announce that the Association of General Contractors honored ODOT's Sallisaw Residency and Manhattan Road \& Bridge Co., of Tulsa with the Pharaoh Award for the replacement of the Combs Bridge over the Illinois River on County Road 569 north of Tahlequah in Cherokee County. The award recognizes the bridge contracting firm and resident engineer completing construction on the highest quality bridge structure in the State. The more than $\$ 2.8$ million project replaced a structurally deficient truss bridge with a modern structure on a new alignment. Construction began in 2014 and the new bridge was completed in summer 2016. The project faced significant environmental and weather challenges, including heavy flooding on the Illinois River in 2015. The project was funded through the State's CIRB program. Accepting the award for Division 1 was Division Engineer, Chris Wallace, District 1 Commissioner, John Fidler, ODOT Sallisaw Residency Inspector, Robert Vinson, and Sallisaw Resident Engineer, Carl Edwards.

## 180. Director's Report

Director, Mike Patterson thanked the Commissioners for the awards that they had just approved. There was a project in there that's significant to this Agency, and certainly to the State; and it's at $\mathrm{I}-35$ and I-240, it's the eastbound to southbound connection. This is the next phase in that whole reconstruction of the I-240 to l-35 interchange; and it is one of the most dangerous locations we have in the State of Oklahoma. We have been working on this for many, many years; Secretary Ridley knows full well what I'm speaking of. This is just that final construction that can really be a game changer for the Oklahoma City area, and certainly the intersection of two interstate highways. So thank you for allowing us to continue with that.

During the legislative session, part of the compromise was that the Department would provide some cash and revenues and be offset with the bond issues. As you know, we issued our bonds and closed on those a couple of months ago. One of the provisions was that on December 1st, the Office of Management Enterprise Services would come get $\$ 200$ million from us, and they did so on December 1st. So we're going to continue to work through those cash flow challenges that that presents to us. But I just wanted to let you know that was the next thing in the budget compromise that would occur, and it did in fact occur. So there are a lot of State Agencies here in Oklahoma that is happy that happened. In fact, I got a couple of emails that day telling us thank you for being part of that compromise and helping those Agencies continue their operations.

The last thing I want to mention is there's been a lot of discussion recently by the Incentive Review Commission about the Industrial Access Program. Well, last week, the Commission decided to not take the recommendation of the Consultant, and will keep the Industrial Access Program in place. So we will continue with this program until told otherwise. This program has proven to be a very effective and efficient way to help mitigate traffic issues when industries move to Oklahoma; and we can provide those safety accesses that we need to before, rather than later, after something catastrophic occurs.

Information Only: No Commission action required.
Commissioner Burrage commented, "That it continues to be an honor to serve with such a talented and professional organization as you guys have; and your leadership this year and past years have been excellent"! He then called on Secretary Ridley for a few comments.

Secretary Ridley said l've been known as a "Starter", but Director Patterson is becoming quickly known as the "Finisher". He and I drove the connection that David Streb, John Bowman, Tim and a lot of other folks, that have all worked on for years on the connection on the east side of Oklahoma City Crosstown that ties the downtown Oklahoma City area back to Interstates, I-235, I-35 and I-40. When that was all being built and laid out, I wasn't too sure how all that was going to work. But Director Patterson and I drove that the other day; and I want to tell the Designers, the Contractors and the Thinkers, that it all works very, very well. You all opened it without a ribbon cutting and a big fanfare; but I think people need to recognize that it works pretty smooth, and it was a long time coming. I am sure proud of the Department in completing that section and in getting ready for the final section, which is the Boulevard itself. But again, congratulations to the Agency for that connection, we really appreciate that.
