Commissioner Burgess said, "I'd like to personally thank all of the Committee Members that were on that Audit Committee; I know that's it's a tough job and we thank you very much for your service".

Commissioner Regan said, I would also like to thank the ODOT team, we have 4 members on that Committee, we are required to have at least 2, but we have 4 to have collaboration and some redundancy and we take it very seriously, and we appreciate everything you all have done. We are required to meet twice a year, and we'll meet this calendar year probably, I'm guessing 8 to 10 times. We've made some
changes; we've worked on the backlog, and so as the Chairman of that Committee I just want to let you know I appreciate it. It's one of those jobs that are a little bit thankless sometimes because it's like the CIA, you can't celebrate your victories, but if you make a mistake, everybody knows about it; and we appreciate everything you've been doing behind the scenes.

## ITEM PRESENTED BY THE DIRECTOR - Mr. Patterson

## 101. Director's Report

Director Patterson said that normally, at this time each year, we are working on rebalancing, reprioritizing the 8 Year Plan. I wanted to report to you that the Division Engineers are going through that process. So we will be setting some schedules with you for early fall, late summer, to come out and visit with you and show you what we have come up with. There was some discussion early on, given the budget situation, whether we would even go through the process, but we've decided to go through the effort. We need to make sure we're still heading in the right direction and that all of our budgets for each project are at the adequate level. So we're going to go through that, and we'll report back to you individually and as a Commission.

This last session, during the budget process, there were a couple of things that happened. One - there was a Bill passed, and according to recent reports from Volvo, the automobile manufacturer, this Bill that passed was exactly the right thing to do. We knew it was at the time, but both the Chairman of our Appropriations Committees in the House and the Senate, Senator Bice and Representative Roberts, authored the Bill, and passed the Bill that began assessing a fee on hybrid vehicles and all electric vehicles. At the time, we knew that Tesla had already pre-sold 400,000 units of their new Model 3; and that's to go with everyone else's electric vehicles that are already on the market. But then Volvo, about 5 days ago, announced that by 2019, all of their vehicles will be either hybrid or electric. So we're seeing that movement toward getting away from fossil fuel vehicles into electric vehicles; and when you're talking, you might say, well, Elon Musk and what he's doing with the Tesla; okay; but when Volvo does it, when they say, that what's going to happen, that's what's going to happen! So kudos to our 2 Chairmen for doing what they did and setting about a notion that revenue for transportation is going to have to change from the gasoline tax and the diesel fuel tax in the future.

The other thing that happened during the budget process; and I have mentioned this a couple times previously; this Agency gave up $\$ 206$ million during the budget compromise; $\$ 50$ of that came out of the County Program, $\$ 3$ from Weigh Station Revolving, and then $\$ 153$ out of the Highway Program. Last year, there was a date certain identified in the Appropriation Bill that we would lose $\$ 200$ Million Dollars. This year, they didn't have that. So we have worked out a payment plan that will soften the blow to this Agency in terms of our cash flow. We worked that out with the Office of Management Enterprise Services, and then they can provide that funding onto the appropriate State Agencies. So it's going to help them get the money when they need it, and will help us give up the money when we can afford to do so. I know there's been some concern about our cash flow situation, and I think we've got this settled at this time.

The other thing is we have a couple of major projects here in Oklahoma County, Oklahoma City to be specific, the one on I-35 and I-240 Interchange. This Commission awarded that Contract a couple of months ago, and the Contractors have gotten started. It is the first movement, and I think it's probably the most important movement in the whole interchange, and that is the Eastbound to Southbound movement. It has been a high accident location with extensive injuries and some fatalities. It is the one component of this, that needed to be fixed, and so we're fixing it first. The entire interchange will take multiple years to get reconstructed, configured to the modern day transportation interchange that it needs to be, but kudos to ODOT to getting this part of it done.

The other one is the I-235 project over here at I-44, and we've talked about it before. Last month we were going to close it for 5 days, but our Contractor, Allen Contracting, finished early and was awarded a very
beneficial for us incentive, because it allowed the traffic to get back onto l-235. That project is weeks ahead of schedule, and we're very happy about that; hopefully, we can maintain this momentum.

If you drive through the Construction Zone, and we hope you don't; but if you do drive through the Construction Zone, you will see the railroad bridge under construction off to west side of the highway. Eventually, just to remind everybody, that bridge will be picked up and moved into position to replace the current railroad bridge that crosses I-235. That will be something new for Oklahoma; it's been done in other states, Utah being maybe the most predominant one to ever use that technology. We're getting anxious to see that happen, and we're going to put it in place and see how this work, see if we can use it in other locations in the State.
