24. Director's Report

Director Patterson said before I give my report, I want to recognize a young man who is attending his last commission meeting as an ODOT employee. Craig Moody, if you would stand up please; I would like to thank you for your 31 years of service; Craig is retiring at the end of February. The last few years, he's been in charge of our Rail Programs Division, provided that leadership, but I want to take you back to what that looked like. That looked like selling a major railroad between here and Tulsa; leading the effort to provide

additional rail crossings safety programs to the State of Oklahoma; continuation of fathering, mothering, the Heartland Flyer to make sure it operates on a daily basis, dealing with Amtrak and the BNSF. So Craig, after 31 years I just want to offer my deep appreciation in front of the Commission for what you've done for the Department of Transportation and the State of Oklahoma. Thank you!

Chelley was up here talking about the upcoming lettings. Last month we talked about the Continuing Resolution, but at the time we were in the middle of a government shutdown. At the end of this week on Friday, the current Continuing Resolution expires. Certainly, we hope beyond all hope that we would have a fully funded for the balance of the federal fiscal year budget; I don't think that's going to happen. Our next best effort would be to get another Continuing Resolution. As we look at Continuing Resolutions, it's become the new normal; but let me talk about Continued Resolutions in this case that we are dealing with. The Highway Trust Fund has lots of cash. It doesn't always have lots of cash, but it has lots of cash in it. So as we continue to do our daily work and we send the bill to the Federal Highway Administration, they have the cash to reimburse us. What we do not have is the budget authority from Congress, the authorization to use any more of the cash. And so that's why we continue to come up here and Chelley and her team juggling projects, tried to get around the barn swallows. So we got issues we are dealing with, environmental issues getting crops to market and we've got school district issues. So we're all trying to time all this, and we're pretty good at timing this until we don't have any money to time it with. So there's part of our dilemma right now. I'm just hoping that next Friday we get a good Continuing Resolution. I don't think we're going to get the budget, but I just hope we get a good Continuing Resolution, not a less than a month, 6 months would be nice, and that would get us to the end of the fiscal year. Now, we would like to have something we could really work with and get some of these projects let.

You recall a few months ago we unveiled our GO-DOT vehicles, and we were using them on our I-235 project. Allen contracting, Jeff Allen's in the room as well, but Jeff helped us get those first GO-DOT vehicles with the cooperation of the Federal Highway Administration; and I know Basharat Saddiqi is sitting in the audience as well. So we got our first 2 GO-DOT vehicles, and they stayed in the confines of the I-235 project that we just opened a few months ago. Well, on the 14th of January, we set them free; in essence, they are now outside the confines of that 1 particular project. We now have 8 operators and a full time dispatcher, and our 8 operators are the guys that you really want to be the operators. We have 3 of them in the room, you guys please stand. See, these are firemen and retired firemen, when they get out of the truck, they bring comfort to whoever is stranded. That's the kind of guys that we wanted for our GO-DOT team, and that's the kind of guys we got. We currently operate from 6:00 a.m. 7:00 p.m. We've had more than 200 motorist contacts where we've pulled over and helped somebody out. And the nice thing about that and we've talked about this, but it's so important, because if somebody is stranded on the side of the road, everybody wants to slow down to look at them and see who it is. Well, then that causes other problems on the main way so we want to get that cleared up and get people on their way. As I said, we have 2 vehicles here in Oklahoma City; and we are working on acquiring 2 more vehicles for the Tulsa area. And then we are just going to expand this on out; because it is something that we think that could really benefit the traveling public, not only for safety but for convenience. On top of that, we have been involved for a number of years with Traffic Incident Management (TIMS). We have become one of the preeminent national leaders in our TIMS. This is where we're working with other first responders, ambulances, law enforcement, fire, and we're setting up a protocol that we can safely go in and secure an area, get it cleaned up, and get it moved as quickly as possible. ODOT, as I said, has become a leader in the nation in this effort; all for the same reasons that we have the GO-DOT; for the convenience and safety of the traveling public.

NOTE: Commissioner Alexander asked who funds the GO-DOT vehicles.

Director Patterson said the Department of Transportation does. Additionally, we used some of our federal funds to purchase the first 2 vehicles, but here on out it's going to be funded with state funds.

Commissioner Burrage thanked the GO-DOT guys for being here today; and thank you for what you do and what you've done in the past. We know you guys have all been in this business a while of helping people.

Director Patterson said I know the next agenda item talks about my replacement. It is a decision that I contemplated on for a number of months. I privately told the Commissioners at the last Commission Meeting of my plans; and then I told the ODOT team shortly after that. So I want to thank you if you're able to find a Director at this Executive Meeting or perhaps the next one. I look forward to working with the next Director to get some transition going, so that as I walk out the door, the new person knows what's going on. Thank you.

NOTE: Commissioner Burrage said we won't go into your long list of accomplishments and how long you've been here, but it's been a long time. There have been so many things that you've been a part of and led; and you done an excellent job in leading this Department; we just don't have time in this meeting to list them. We cannot express our appreciation enough for your service. Very few devote their lives and handle it in the manner that you have in your public service. Director Patterson you are an example to others, and many have watched how you've handled yourself and have modeled themselves after you. You know ODOT has a history of people staying and working here and doing great things, and you're going to fall right in line with that group.

Commissioner Burgess said when I showed up 16 years ago, I remember what the Department was like and how many bridges were functionally obsolete and structurally deficient. I remember you and Gary Ridley working so hard with the Governor and the Legislature to fix these problems. To see it now, is just unbelievable and you guys have every right to be so proud of yourselves. We are just so proud of you and Secretary Ridley for what you and your team have done. Oklahoma is in a much better place than we were 2 decades ago, and for that we thank you.

Commissioner Love said my company operates in 42 states; and one of the things that I personally do is develop the locations, and probably the hardest this we do is to get the driveway permits. And many times, I have to go all the way up the top the food chain in California, Arizona, Illinois, and I would talk to Director Patterson. He would give the Director from that particular state a heads up that I would be calling. It was very apparent in talking to those head of DOT's that Mike has a great reputation within that world; and I think that kind of speaks volumes.

Secretary Ridley said Mike you have done so much during the time that I've been here. The success that I've had is because of the hard work you have done. I just want to tell you how much we appreciate not only the work that you've done here but also the work that you do in the Community. You will always be a friend of everybody here and I just want to wish you well.
