172. Authority to Enter into Agreements for TIFIA Two Lane – Ms. Hilmes

This request for authorization is to support the TIFIA Loan Agreement to be entered into by the Oklahoma Capitol Improvement Authority (OCIA) and the U.S. Department of Transportation (USDOT) pursuant to Title 73 Oklahoma Statutes 2021, Section 350.1, and the Resolution adopted by OCIA on September 8, 2021 as amended and restated by the OCIA Board on April 12, 2022. Debt service on the associated TIFIA Note (the second under the Resolution) will be payable from and secured by increased payments to OCIA from the Oklahoma Department of Transportation (ODOT) pursuant to that certain Lease Agreement for Use and Possession between OCIA and ODOT dated May 27, 2022, as contemplated by the Resolution (Lease Agreement). ODOT, through the Director of ODOT, requests authorization to negotiate the terms and conditions of, and to execute and deliver a direct agreement between ODOT, OCIA and USDOT to provide certain assurances and agreements with respect to the Lease Agreement and the transactions contemplated thereby and such other documents, agreements and certifications as may be necessary or required in connection with any of the foregoing financing agreements.

174. Director's Report

Secretary Gatz thanked the Commission for their consideration of several significant projects that are going to definitely have an impact on our transportation system. The projects are:

- SH-66 widen, resurface, bridge, grade, drain and surface project east of I-35 between Post Road & Westminster Road in Edmond. It will certainly enhance the safety in the Route 66 corridor and be completed before the 2026 Centennial Celebration. It's a \$31 million project and estimated to start in Spring 2023 and complete in 2025. One lane open in each direction at all times during construction.
- I-40 ITS (Road Weather Information Systems) from the Texas state line to the Arkansas state line. The cameras are about every 30 miles along the I-40 corridor at bridges to measure pavement surface condition, as well as the temperature 2 inches below the road surface and is especially focused on bridges. It also measures precipitation and wind speed. The cameras at each location captures images of the road conditions every 10 minutes and are part of the www.okroads.org inclement weather road conditions map. This is the 2nd phase of a larger Road Weather Information System deployment project; the 1st phase was in 2018 on I-35. This very important technology that helps us make good decisions, not just with inclement weather, but in particular, when we have those wintertime events, that it's extremely important for us to know exactly when we experienced freezing conditions at the pavement level. This is a \$1.3 million project and work on this is expected to start in early 2023 and finish sometime next summer. Not tremendous traffic impacts, other than some potential, periodic lane closures.
- ITS (CCTV installation) of 11 new traffic camera locations, that will be installed in Cleveland, McClain, Oklahoma, and Canadian counties. These cameras will be part of the www.oktraffic.org; and DRIVE Oklahoma Mobile App. This is a \$1.7 million project estimated to begin early 2023 and completed by summer 2023.
- US-77/Broadway Extension, asphalt resurfacing project from Memorial Road extending north in Edmond. This is about a \$9 million project estimated to begin early 2023 and anticipated completion by fall 2023. There will be nighttime lane closures and impacts to driveways along the business route But Division 4 has done a good job of getting out ahead of this, and talking to business owners, and certainly opening solid lines of communication back with the community. Motorists can also expect some rough-pavement conditions in the area as we progress the project. We will do our best to have night work, where that's possible, to minimize traffic disruptions. So again, just want the public to be aware of that.
- I-40 asphalt resurfacing 3.5 miles near Webbers Falls, in Muskogee and Sequoyah County. It is about a \$4 million project and there will be some lane closures and will certainly cause traffic problems.

We are continuing with our Safety Campaign; and this month's emphasis will be on wearing your seatbelt, especially with all the holiday traveling. The Director presented a PSA about the Work Zone Safe Program that prepares teen drivers on how to navigate work zones safely. This

Secretary Gatz reminded Commissioners that beginning with 2023 we are going to start having 2 bid lettings per month. This will provide contractors with more opportunities to competitively bid on projects each month.

NOTE: Commissioner Grimsley commented about the ITS & Weather Modernization stuff. Just for the benefit of the Commission, a couple of years ago our Legislature passed a pretty innovative bill (the Advanced Mobility Pilot Program Act). And part of that encapsulates where we have the emerging aviation side, and we have the emerging ground transportation side, actually kind of working side by side. So, I think it would be beneficial in the future if we had a presentation about the assets that we do have, i.e., fiber, dark fiber, spectrum, those things that come into play for ITS, but also are going to be really important for all the emerging transportation and stuff in the future. Oklahoma was one of the 1st states to enact that type of legislation and several states, including Texas modeled what we did. This is something that we have the potential to be a leader; so, if we could have a presentation in the future on the assets that we have, I think it will be very useful to us.

And then secondly, I've said it before, but the Social Media Campaign on remembering and the Memorials on the Work Zone Safety is very compelling because it does put a face and it makes it very personal. District by district, you see the impact, and it's staggering when you see over a year, the anniversaries of these horrible accidents and tragedies that happened. So, I think it's a very important campaign that ODOT does; and it's something to be mindful of if you're on social media, to watch that. It has an effect! Thank you.

Secretary Gatz said, thank you Commissioner; and for the Advanced Mobility Advisory Council, we absolutely will make that happen, because we need to understand opportunities to leverage these resources that we have. And certainly, these weather-information systems are critical to our unmanned aerial systems in the future, along with that bandwidth that you're talking about. So, we will absolutely make that happen.
