Hand Delivered bids will be received at the Oklahoma Department of Transportation Building, Right-of-Way & Utilities Division, 200 N.E. 21st Street, Room 1-B7, Oklahoma City, Oklahoma 73105 on July 13, 2023 until 1:30 PM CST. The bids will be opened and immediately read publicly on July 13, 2023 at 1:30 PM CST. at the address above.

Description of Property:

A strip, piece, or parcel of land lying in part of the NW/4 of Section 9, T6S, R9E, in Bryan County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

BEGINNING at the SW corner of said NW/4; thence N00°38'57"W along the West line of said NW/4 a distance of 115.08 feet to a point on the Present East Right-of-Way line of SH-78; thence N11°43'12"E along the Present East Right-of-Way line of SH-78 a distance of 331.82 feet; thence N06°16'10"E along the Present East Right-of-Way line of SH-78 a distance of 222.46 feet; thence N88°51'59"E a distance of 219.21 feet to a point on the East Right-of-Way line of the abandoned Missouri Pacific Railroad; thence S20°54'19"W along the East Right-of-Way line of the abandoned Missouri Pacific Railroad a distance of 714.81 feet to a point on the South line of said NW/4; thence S89°06'49" W along said South line a distance of 54.85 feet to said **POINT OF BEGINNING**.
