Bid proposals sent by REGISTERED MAIL will be received through the Oklahoma Department of Transportation, Facilities Management Division on **September 08, 2022 until 1:00 PM CST.** Hand Delivered bids will be received at the <u>Oklahoma Department of Transportation Building, Facilities Management Division, 200 N.E. 21st Street, Room 1-B7, Oklahoma City, Oklahoma 73105 on **September 08, 2022 until 1:30 PM CST.** The bids will be opened and immediately read publicly on **September 08, 2022 at 1:30 PM CST.** in the ODOT Project Management Conference Room located at the address above.</u>

## Description of Property:

A strip, piece or parcel of land lying in part of the N½ NE¼ SE¼ NE¼ of Section 23, T10N, R2E in Pottawatomie County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Commencing at the NE corner of said N½ NE¼ SE¼ NE¼, thence S 89°31'08" W along the North line of said N½ NE¼ SE¼ NE¼ a distance of 91.30 feet to a point on the present West right-of-way line of State Highway No. 102, said point being the point of beginning, thence continuing S 89°31'08" W along said North line a distance of 568.49 feet to the NW corner of said N½ NE¼ SE¼ NE¼, thence S 00°27'44" E along the West line of said N½ NE¼ SE¼ NE¼ a distance of 329.15 feet to the SW corner of said N½ NE¼ SE¼ NE¼, thence N 89°32'04" E along the South line of said N½ NE¼ SE¼ NE¼ a distance of 569.31 feet to a point on the present West right-of-way line of State Highway No. 102, thence N 00°36'17" W along said right-of-way line a distance of 329.31 feet to said Point of Beginning.

Containing 4.30 acres, more or less.

Grantor reserves and excepts, unto itself, its successors and assigns a PERPETUAL UTILITY EASEMENT on, over, upon and across the East 16 feet containing 0.05 acres of the above described property.

The Oklahoma Department of Transportation has set the **minimum bid** requirement at \$43,000.00 for this sale. The parcel is being sold "as is-where is", with the buyer being responsible for their own due diligence in regards to zoning, licenses, permits, environmental, land uses, etc.

Terms of the sale are ten percent (10%) of the bid price in **non-refundable certified funds** and must accompany each bid in the form of a bid deposit made payable to the "Oklahoma Department of Transportation." The balance of the successful high bid will be due in certified funds within thirty (30) calendar days after the approval by the Oklahoma Transportation Commission, and all **deposits submitted by non-successful bidders will be returned after said approval.** The successful high bidder will also be required to pay for any and all advertising costs associated with the sale of this land. After approval of the sale, an executed and recorded Quitclaim Deed will be mailed to the highest bidder. IMPORTANT: LABEL THE OUTSIDE OF THE ENVELOPE WITH "SEALED BID".
