Bid proposals sent by REGISTERED MAIL will be received through the Oklahoma Department of Transportation, Facilities Management Division on **February 11, 2021 until 1:00 PM CST**. Hand Delivered bids will be received at the Oklahoma Department of Transportation Building, Facilities Management Division, 200 N.E. 21st Street, Room 1-B7, Oklahoma City, Oklahoma 73105 on **February 11, 2021 until 1:30 PM CST**. The bids will be opened and immediately read publicly on **February 11, 2021 at 1:30 PM CST** in the ODOT Project Management Conference Room located at the address above.

Description of Property:

*A strip, piece, or parcel of land lying in W/2 Government Lot 3 (W/2 NE/4 NW/4) and E/2 Government Lot 4 (E/2 NW/4 NW/4) of Section 2, T3S R1E, Carter County, Oklahoma. Said parcel of land being described by metes and bounds as follows:*

*Commencing at the NW corner of said Lot 4; thence N89°27'47"E along the north line of said Lot 4 a distance of 660.00 feet; thence S00°26'58"E a distance of 154.73 feet to a point on the present South right-of-way line of State Highway No. 53, said point being the **POINT OF BEGINNING**; thence N89°26'22"E along said south right-of-way line a distance of 486.44 feet; thence S85°37'09"E along said south right-of-way line a distance of 174.14 feet; thence N89°26'22"E along said south right-of-way line a distance of 66.29 feet; thence N89°29'21"E along said south right-of-way line a distance of 196.28 feet; thence S00°26'59"E a distance of 241.99 feet; thence S89°27'50"W a distance of 653.96 feet; thence S07°20'16"E a distance of 936.16 feet to a point on the south line of said Lot 4; thence S89°14'27"W along the south line of said Lot 4 a distance of 380.85 feet along said south line to the SW corner of said Lot 4; thence N00°26'58"W along the west line of said Lot 4 a distance of 1187.82 feet to the **POINT OF BEGINNING**.*

The Oklahoma Department of Transportation has set the **minimum bid** requirement at **\$200,919.76** for this sale. The parcel is being sold "**as is-where is**", with the buyer being responsible for their own due diligence in regards to zoning, licenses, permits, environmental, land uses, etc.

Terms of the sale are ten percent (10%) of the bid price in **non-refundable certified funds** and must accompany each bid in the form of a bid deposit. The balance of the bid will be due in certified funds within thirty (30) calendar days after the approval by the Oklahoma Transportation Commission. **Deposits submitted by non-successful bidders will be returned.** The successful high bidder will also be required to pay for any and all advertising costs associated with the sale of this land.
