Pursuant to Title 69 Oklahoma Statutes (2021), Section 1001, the Oklahoma Department of Transportation offers the following property for sale by sealed bid to the highest bidder. Bid proposals sent by REGISTERED MAIL will be received through the Oklahoma Department of Transportation, Right-of-Way & Utilities Division on January 11, 2024 until 1:00 PM CST. Hand Delivered bids will be received at the Oklahoma Department of Transportation Building, Right-of-Way & Utilities Division, 200 N.E. 21st Street, Room 1-B7, Oklahoma City, Oklahoma 73105 on January 11, 2024 until 1:30 PM CST. The bids will be opened and immediately read publicly on January 11, 2024 at 1:30 PM CST. at the address above.

Description of Property:

A strip, piece, or parcel of land lying in part of the S/2 SE/4 SE/4 of Section 9, T21N, R15E, in Rogers County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

BEGINNING at the NW corner of the S/2 SE/4 SE/4 SE/4 of Section 9, T21N, R15E; thence S 01°26'19" E along the West line of the S/2 SE/4 SE/4 a distance of 74.32 feet to a point on the Permanent North Right-of-Way line of SH-20; thence S 83°58'50" E along the Permanent North Right-of-Way line of SH-20 a distance of 363.71 feet to a point on the Permanent West Right-of-Way line of County Road 4100 (Keetonville Road); thence N 03°24'56" W along the Permanent West Right-of-Way line of County Road 4100 (Keetonville Road) a distance of 120.87 feet to a point where the Permanent West Right-of-Way line of County Road 4100 (Keetonville Road) intersects the North line of said S/2 SE/4 SE/4 SE/4; thence S 88°39'53" W along the North line of said said S/2 SE/4 SE/4 SE/4 SE/4 a distance of 356.46 feet to said **POINT OF BEGINNING**.

Containing 0.80 ac. (34,913.82 sq. ft.), more or less.

The Oklahoma Department of Transportation has set the **minimum bid** requirement at \$16,800.00 for this sale. The parcel is being sold "as is-where is", with the buyer being responsible for their own due diligence in regards to zoning, licenses, permits, environmental, land uses, etc.

Terms of the sale are ten percent (10%) of the bid price in **non-refundable certified funds** and must accompany each bid in the form of a bid deposit made payable to the "Oklahoma Department of Transportation." The balance of the successful high bid will be due in certified funds within thirty (30) calendar days after the approval by the Oklahoma Transportation Commission, and all **deposits submitted by non-successful bidders will be returned after said approval.** The successful high bidder will also be required to pay for any and all advertising costs associated with the sale of this land.
