Pursuant to Title 69 Oklahoma Statutes (2021), Section 1001, the Oklahoma Department of Transportation offers the following property for sale by sealed bid to the highest bidder. Bid proposals sent by REGISTERED MAIL will be received through the Oklahoma Department of Transportation, Right-of-Way & Utilities Division on January 12, 2023 until 1:00 PM CST. Hand Delivered bids will be received at the Oklahoma Department of Transportation Building, Right-of-Way & Utilities Division, 200 N.E. 21st Street, Room 1-B7, Oklahoma City, Oklahoma 73105 on January 12, 2023 until 1:30 PM CST. The bids will be opened and immediately read publicly on January 12, 2023 at 1:30 PM CST. in the ODOT Project Management Conference Room located at the address above.

Description of Property:

A strip, piece or parcel of land lying in part of the W½ E½ SW¼ SE¼, Section 18, Township 26 North, Range 14 East, I.M., Washington County, Oklahoma. Said parcel of land being described by metes and bounds as follows:

Commencing at the Southwest corner of said W½ E½ SW¼ SE¼, thence N 01°20′18″ W along the West line of said W½ E½ SW¼ SE¼ a distance of 119.37 feet to the point of beginning, thence continuing N 01° 20′18″ W along said West line a distance of 309.53 feet, thence N 88°39′42″ E a distance of 110.19 feet, thence S 01° 47′25″ E a distance of 303.82 feet to a point on the permanent North right-of-way line of U.S. Highway No. 60, thence S 85°45′11″ W along said North right-of-way line a distance of 112.73 feet to the point of beginning.

Containing 0.78 acres, more or less.

The Oklahoma Department of Transportation has set the **minimum bid** requirement at **\$4,700.00** for this sale. The parcel is being sold **"as is-where is"**, with the buyer being responsible for their own due diligence in regards to zoning, licenses, permits, environmental, land uses, etc.

Terms of the sale are ten percent (10%) of the bid price in **non-refundable certified funds** and must accompany each bid in the form of a bid deposit made payable to the "Oklahoma Department of Transportation." The balance of the successful high bid will be due in certified funds within thirty (30) calendar days after the approval by the Oklahoma Transportation Commission, and all **deposits submitted by non-successful bidders will be returned after said approval.** The successful high bidder will also be required to pay for any and all advertising costs associated with the sale of this land. After approval of the sale, an executed and recorded Quitclaim Deed will be mailed to the highest bidder. IMPORTANT: LABEL THE OUTSIDE OF THE ENVELOPE WITH "SEALED BID".
