RE: Oklahoma Department of Transportation INFRA Application for I-40 and Douglas Blvd. project in Oklahoma County

Dear Secretary Chao:

I am pleased to submit a letter of support for the Oklahoma Department of Transportation's Infrastructure for Rebuilding America (INFRA) grant application for the I-40 and Douglas Blvd. project in Oklahoma County.

The Oklahoma Department of Transportation would use these grant funds to advance reconstruction and widening of more than five miles of I-40 from four lanes to six lanes in Oklahoma City and Midwest City, including rebuilding the I-40 interchange at Douglas Blvd as a Single Point Urban Interchange and addressing vertical clearance of several bridges over the interstate. This corridor and the Douglas Blvd. interchange directly serve Tinker Air Force Base, the largest single-site employer in Oklahoma that draws thousands of commuters and materials suppliers each day. Tinker AFB supports critical national defense missions worldwide and drives Oklahoma's private sector aerospace engineering and manufacturing industry.

ODOT is investing considerable resources to improve the corridor in this area, with several ongoing and planned projects to widen the interstate to six lanes between Oklahoma City and Shawnee to support growing freight and commuter traffic. Additionally, the Oklahoma Turnpike Authority's new 21-mile Kickapoo Turnpike between I-44 and I-40 on Oklahoma City's east side is scheduled to open in late 2020 and expected to generate significant volumes of new traffic connecting with I-40 just a few miles east of Douglas Blvd. It is critical to address this outdated and insufficient segment of I-40 now, as traffic volumes are expected to dramatically increase in coming years.

Grant funding for this project would help ODOT address the most challenging segment of I-40 widening in the area and complete the six-lane corridor between Oklahoma City and Shawnee. Additionally, this project serves regional and national economic interests, as I-40 is one of the only all-weather, coast-to-coast interstate routes in the United States.
