Dear Secretary Buttigieg:

We are pleased to write this letter in support of the Oklahoma Department of Transportation's (ODOT) application for the Multimodal Project Discretionary Grant (MPDG) program. The *Hochatown Community Access and Pedestrian Safety Project* will expand a section of highway in rural Southeast Oklahoma which has seen substantial growth over the past decade.

Hochatown has become a popular attraction for many across Oklahoma, Arkansas, and Texas. Home to Broken Bow Lake and Beavers Bend State Park, along with numerous other attractions and businesses, this area of Southeast Oklahoma has become a hub for tourism and economic development. The growth has led to the community of Hochatown incorporating in November 2022, establishing a local government for the first time which lacks the resources to develop the highway infrastructure. The existing two-lane highway lacks shoulders and turn lanes which has increased the collision rates and restricts movement. The increased development and tourism have displayed the current lack of capacity and the need for major improvements.

The project proposed by ODOT will upgrade a six-mile section of US-259 by expanding the roadway, providing safety and operational improvements, along with improved access management. ODOT also looks to address alternative, multimodal transportation options by providing accessibility through sidewalks and trails. The improved US-259 will help incentivize economic development and sustain the growth that Hochatown has seen in recent years. Construction of the project will create a modernized, safer expanded highway with a shared-use path to support connectivity along the corridor and improve overall conditions for the community and visitors alike.

Having polled our members, the Oklahoma Trucking Association, believes this project meets the desired goals state for the Oklahoma Department of Transportation's (ODOT) 2023/2024 MPDG RURAL application for the Hochatown Community Access and Pedestrian Safety Project.

As "the voice of trucking" safety is imperative to the industry, and we believe the following to be beneficial: The US-259 corridor through Hochatown experiences collision rates that are 3x higher than the statewide average. The current, two-lane roadway lacks shoulders or turn lanes, making vehicle movements challenging across the corridor. The project will protect nonmotorized travelers and communities from safety risks by constructing crossing improvements, new traffic lights at intersections, and completing a multi-use bike and pedestrian path adjacent to US-259.
