Dear Secretary Buttigieg:

We are pleased to write this letter in support of the Oklahoma Department of Transportation's (ODOT) application for the Multimodal Project Discretionary Grant (MPDG) program. The project aims to revamp the existing highway network surrounding the MidAmerica Industrial Park in Mayes County, including major road improvements to the Highway System and enhancements to local roads.

The MidAmerica Industrial Park is the largest industrial park in the state and is one of the largest parks in the nation. The park is home to over 80 companies and strategically located off of U.S. Highway 69, just south of the City of Pryor and just over 40 miles from Tulsa. The existing local roadway network relies heavily on narrow two-lane roads that feed to the highways that surround the park with little to no access within the core of the property available for new commerce. Additionally, the local roadways are disjointed and have limited access points to the larger highway system, causing delays due to access in and out of the park.

The proposed *MidAmerica Connectivity Project* will improve sections and interchanges on US-412 and US-69 as well as street and trail improvements in and surrounding the park. The improvements also include railroad crossings, pedestrian accommodations, improved shoulders, and a new roundabout intersection with Patrol Road, the southern primary local road within the park. Completion of the project would be a transformative initiative that holds immense potential for rural Oklahoma. By enhancing infrastructure, prioritizing safety, fostering economic growth, and promoting environmental consciousness, this project will pave the way for the MidAmerica Industrial Park and the surrounding communities to continue economic growth and expansion.
