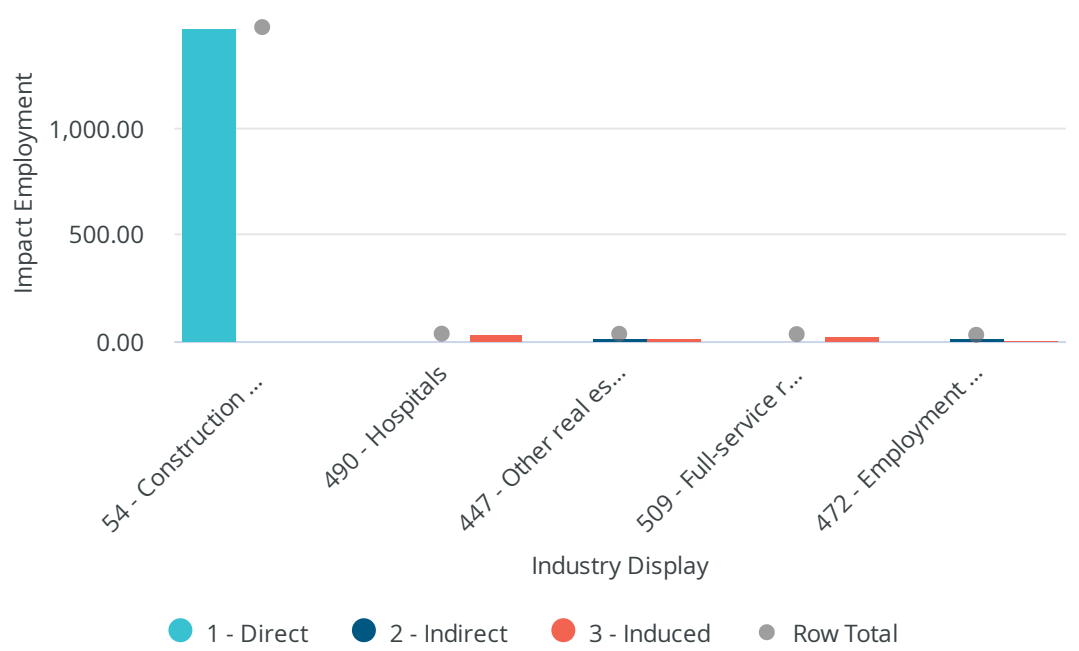

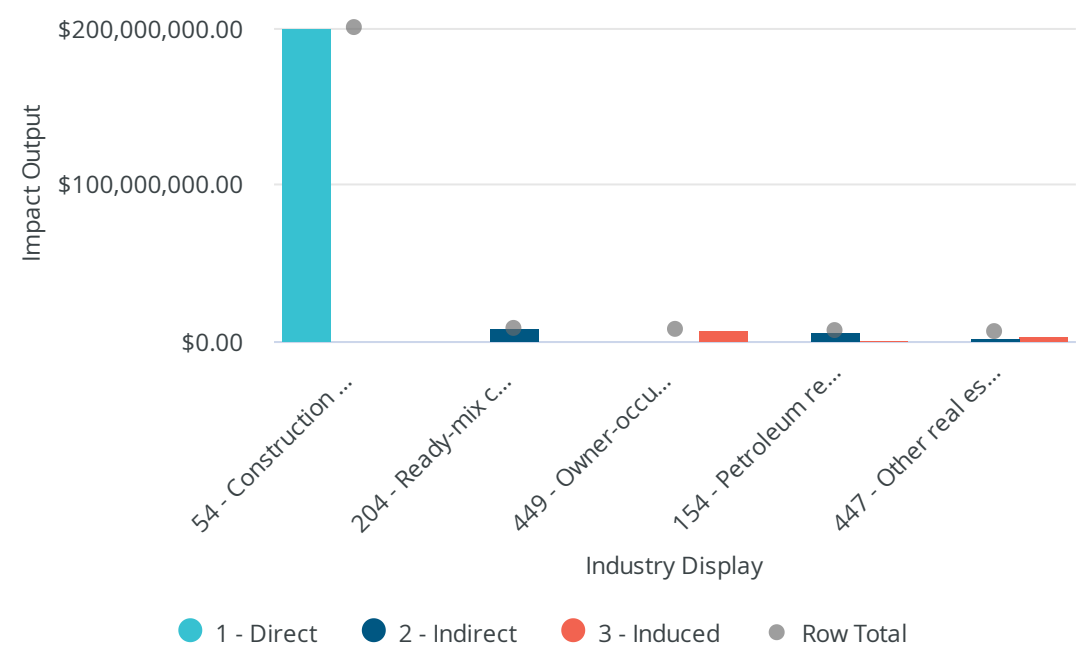

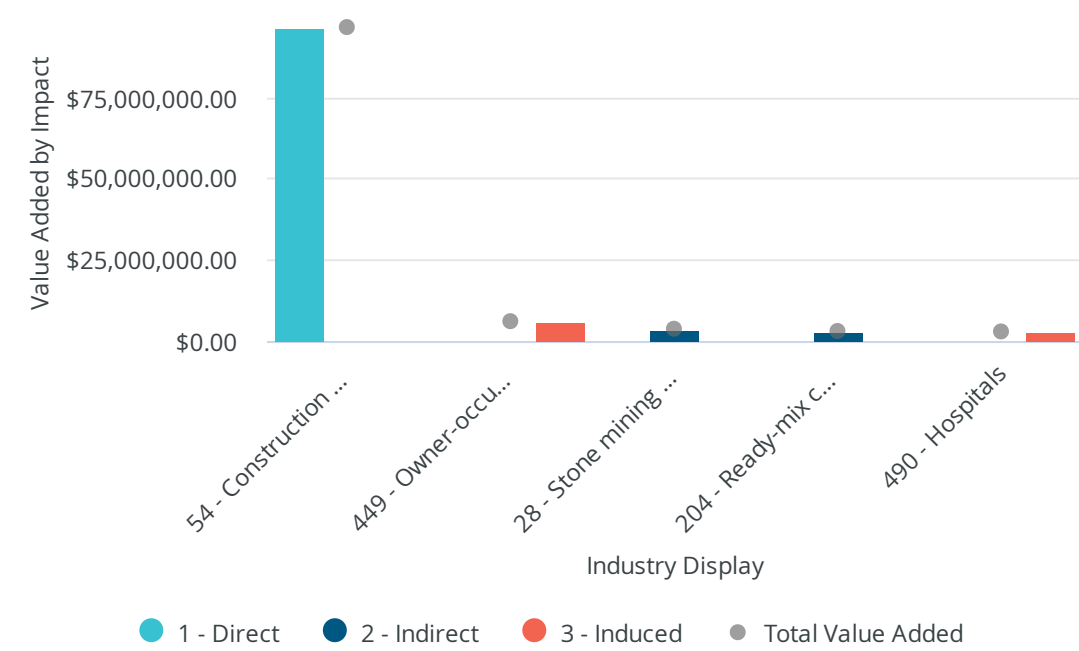
### Top 5 Employment Industries



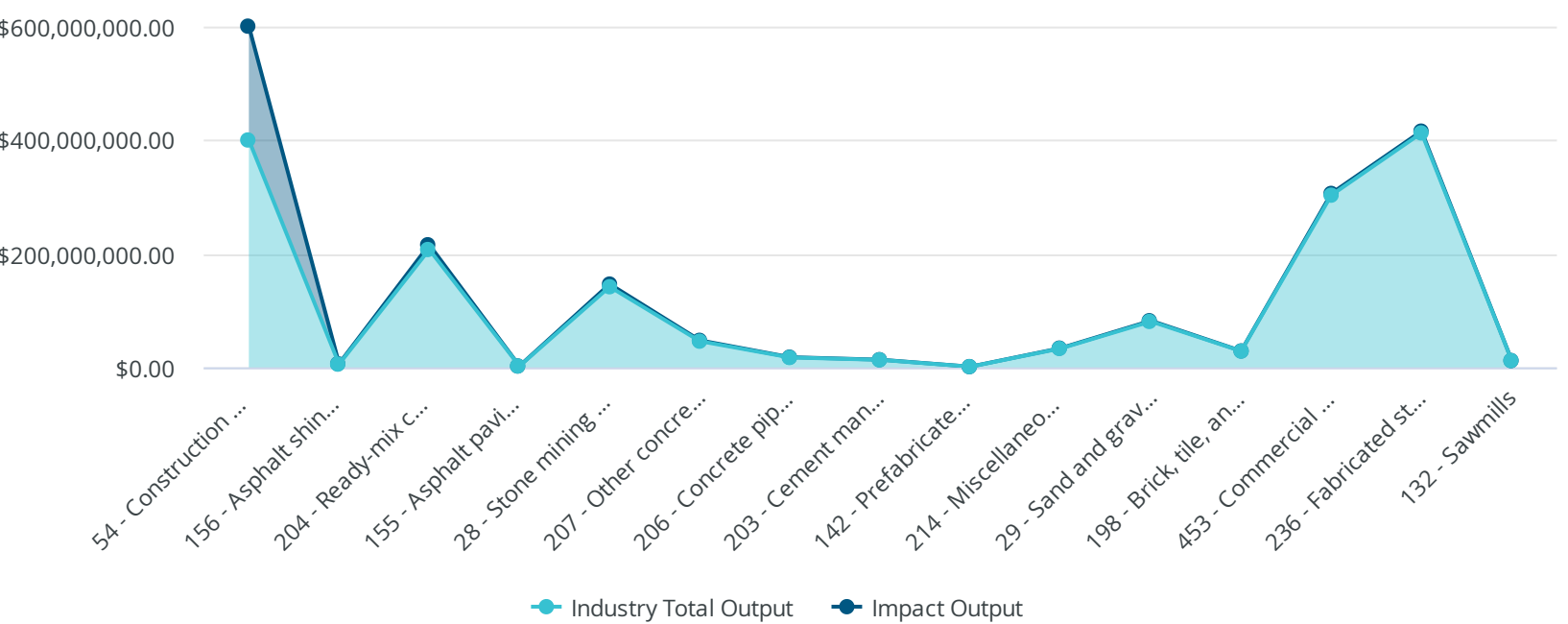
### Top 5 Output Industries
