RE: Rebuilding American Infrastructure with Sustainability and Equity (RAISE) Grant opportunity for **Multimodal Improvements to Safely Connect Tulsa at US-75 and 81<sup>st</sup> Street Interchange**

Honorable Secretary Buttigieg:

As the “*voice of trucking*” in Oklahoma, we represent the unified interest of our member companies that literally have a front row seat to the needs of infrastructure across our state. Having polled our members, the Oklahoma Trucking Association, believes this project meets the desired goals state for the Oklahoma Department of Transportation's (ODOT) application for the RAISE Grant for Multimodal Improvements to Safely Connect Tulsa at US-75 and 81st Street Interchange.

Current conditions make crossing US-75 on 81<sup>st</sup> Street challenging for bicyclist and pedestrians. At this time 81st Street under US-75 has a one-foot shoulder against a retaining wall giving bicycle and pedestrian users very little room to use the facility. There is inadequate room to expand roadway width under the bridge which does not allow for the addition of multimodal infrastructure. A lengthy detour, along with other non-ideal crossing conditions at other locations, discourages alternative modes of transportation and generates a barrier for people without vehicles. This creates isolation for non-motorist users on each side of the highway.

In an effort to provide safe access to economic opportunities along US-75 in West Tulsa, ODOT proposes to reconstruct the interchange with expansion of the US-75 bridge, allowing additional transportation choices. ODOT will tie a multi-use trail along the interchange into the current trail system plans that Tulsa has created. This project promotes a safe network for equitable use to economic opportunities by providing these trail connections. A RAISE Grant award will help ODOT invest in resilient infrastructure that encourages multimodal transportation choices by adding multi-use trails under a new bridge. This network improvement eases the obstacle of crossing US-75 for bicyclist, pedestrians, and other users without vehicles.

The Oklahoma Trucking Association strongly supports the supports the Multimodal Improvements to Safely Connect Tulsa at US-75 and 81st Street Interchange for its vital contribution to the region, state, and nation.
