The Oklahoma Department of Transportation (ODOT) will host a virtual public open house to present an overview of the proposed improvements to US-60 (Broadway Avenue) starting from the junction of US-81 and extending east to Erie Street in Pond Creek, Oklahoma. During construction, US-60/Broadway Ave. will remain open. This open house will present the purpose and need for the project and proposed design, and will allow the public to submit comments. This will be a web-based format. The information will be available beginning April 11, 2023 and comments are requested by April 25, 2023.

## PROJECT OVERVIEW

### Project Limits

From the Junction with US-81, extend east to Erie Street in Pond Creek

### Purpose

Improve the roadway by correcting deteriorating pavement, non-compliant pedestrian access, and poor traffic flow

### Proposed Improvements

- Mill & overlay existing pavement
- Re-stripe driving lanes & parking areas
- Construct medians & curb-and-gutter sections to delineate traffic lanes, driveways and pedestrian areas
- Improve the railroad crossing
- Upgrade the US-81/US-60 intersection to improve drainage, turning movements & traffic flow
