



# ODOT OPEN HOUSE MEETING

## US-64 Improvements • Haskell, OK • J/P: 34380(04)

The Oklahoma Department of Transportation (ODOT) will host an in-person public Open House to present the proposed roadway improvements for US-64 in Wagoner and Muskogee Counties, Oklahoma. The project begins ~½-mile south of the Tulsa County line or roughly three miles south of the community of Leonard and extends ~7.5 miles to the Franklin Street (SH-104) junction in the town of Haskell. At the Open House, the public can ask questions, provide input, submit comments, and learn about the proposed construction activities, sequencing and scheduling. The Open House will be a come-and-go format with no formal presentation. ## PROJECT OVERVIEW

### Project Limits

Begin ~1/2-mile south of the Tulsa County line, and extend ~7.5 miles south to the Franklin Road (SH-104) junction in the town of Haskell.

### Purpose

To improve the mobility & safety of US-64 by correcting deteriorating pavement, poor sight distances, and narrow bridges and drainage structures.

### Proposed Improvements

- Widen US-64 to create two 12-foot-wide driving lanes with 6-foot-wide paved shoulders
- Realign angled intersections, roads, drives & entrances
- Lengthen the box bridges to match roadway width
- Improve the function of the US-64/Franklin Road intersection
