QUESTIONS AND ANSWERS

- Q 1: The plans identify storm piping "SD," but the size and material are not identified. Can that be provided?
- A 1: Size is identified on sheets CG201 and CG202. An addendum will be issued to show material; all storm piping smaller than 12" diameter is to be HDPE.
- Q 2: There is no place on the pay items for the storm sewer and manholes. Only the 140' of 12" RCP and end sections are shown for storm sewer. Please provide a line item for this storm drainage/manholes.
- A 2: An updated pay item list will be provided.
- Q 3: Are there any drainage structures behind the Hopper Rack? Plans indicate a storm drain line directly behind the Hopper rack, but there is no provision for collecting drainage at this location.
- A 3: The hopper racks are equipped with drains for each bay. An addendum will be issued to reflect this correction.
- Q 4: The pay item sheet appears to have a couple of errors: Please address.
- Flexamat ditch liner says 7535.44 square yards, but according to our take-offs, it should be closer to 1595 sq yards.
- Select Fill line items does not have a listed quantity.
- Site Storm Sewer line item does not account for the manholes. Where do we provide pricing for manholes?
- Mobilization line item says 4% and Bonds & Insurance says 2%. If the intent is to say that we are limited to charging 4% and 2% respectively, for those two categories, but it would be easier if we could list those two items as a lump sum with the understanding that we can't bill more than 4% for mobilization and 2% for bonds/insurance.
- Sanitary sewer line item says it is 6", but the plans call for 4" sanitary sewer lines.
- There is a pay item for Sod, 7535.44 square yards, but the plans don't call for any sod. There are notes about all disturbed areas being seeded unless otherwise noted. Please clarify where sod is located and where seeding will be required and also provide the pay item for Seeding.
- There are no pay items for the following: generator pad, transformer pad, light pole bases, and CORS Tower.
- A 4: Flexamat ditch liner: quantity should be 1595 SY. An updated pay list will be provided.

Select fill: quantity should be 13,380 CY

Storm sewer manholes: An updated pay item list will be provided.

Sanitary sewer lines: An updated pay item list will be provided; 4" sanitary lines will be added.

Sod/Seed: An addendum will be issued that changes all references for seeding to sodding.

Pad/Bases/CORS Tower: An updated pay item list will be provided that includes these items.

- Q 5: There is no erosion control plan or silt fence called out on the plans. Please provide an erosion control plan.
- A 5: An addendum will be issued that includes an erosion control plan.

Q 6: Are there any additional specifications for the Fuel Tank system beyond the notes on C-503?

A 6: Specifications for the footings, slab, and related requirements fall under the responsibility of the tank manufacturer.

Q 7: Is there a list of approved ODOT fuel system vendors available?

A 7: No

Q 8: Can you provide any manufacturer or more specific information for the fueling system other than the tank capacity and the requirements listed in Notes #1-#3 on C-503?

A 8: Specifications for the footings, slab, and related requirements fall under the responsibility of the tank manufacturer.

Q 9: Can you please provide a geotechnical report for this project?

A 9: Included and attached.

Q 10: Are the building widths hard-set at 42' and 60', or would 40' or 62' also be acceptable if that is the standard width available from our supplier?

A 10: The building widths as shown on the bid documents shall be followed.

Q 11: Is the 12' Truss spacing a hard-set requirement, or are other spacings acceptable as long as they are engineered and have sealed drawings?

A 11: Truss spacing of 12'0" is required.

Q 12: Is a fabric back-end wall needed for either building? Are there any mesh vents or framing for fans?

A 12: Yes, fabric back endwall is required on both buildings and vents to be provided by fabric structure manufacturer, including size and installation requirements.

Q 13: Is a front-end wall needed for either building? Door opening? Fabric Gather Door? Vents?

A 13: No

Q 14: Is the project tax-exempt?

A 14: The State is tax-exempt. That status does not extend to the awarded contractor.

Q 15: What trade are you wanting to pick the drainage ditch with - flex mat, dirt contractor, utilities, or someone else?
