## 160. Addition to the Industrial Access Road Program

## Commission District IV - Garfield County

The City of Enid is requesting approval for an industrial access project for Takkion Energy. Takkion is investing $\$ 33$ million in the new facility and creating 80 new full-time jobs. This facility will be nation's first commercial gearbox testing facility capable of handling wind turbine equipment and will provide service to existing wind farms within a 300 -mile radius of Enid. Facility construction began in October 2022 and is expected to conclude in approximately September 2023.

The proposed project begins at the intersection of State Highway 412 and South $54^{\text {th }}$ Street and extends approximately 1.0 miles south to East Market Avenue. The city of Enid will be responsible for initiation, construction and completion of all work associated with the project. The total cost of project is estimated at $\$ 1,249,100$. The Department's participation in the project shall not exceed $\$ 954,779$.

NOTE: Commissioner Peterson asked who is making up the difference between the $\$ 1,249,100$ and ODOT's participation amount of $\$ 954,779$.

Ms. Wheeler said the City of Enid is paying the difference.
Commissioner Grimsley said this program is paying some pretty good dividends; for the amount of money that's going in and I think we are getting some tremendous results back. It's really making our transportation network a lot more efficient; I do want to thank the legislature, Representative Miller and others for helping with this fund, it is working!

## 162. Director's Report

Secretary Gatz informed everyone that former Transportation Commission and Turnpike Authority Board Member, Guy Berry had passed away. (A short moment of silence was held in remembrance of Mr. Berry)

He said ODOT just completed participation in the 2nd Annual Statewide Suppliers Expo. This event was created at the recommendation of Governor Stitt in order to provide a chance for private businesses to explore the opportunities of providing services to state agencies. All 3 agencies from the Transportation Cabinet were represented. Businesses got a chance to meet face to face with Oklahoma Cabinet Secretaries, Agency Directors and team members, to help them learn about business opportunities with the State and learn how to navigate the State's Procurement System. The event was held at the Oklahoma City Convention Center and was well attended by both suppliers as well as state agencies.

ODOT held a groundbreaking ceremony on November 2 for the reconstruction of the Bridgeport bridge. This is the US-281/SH-66 bridge over the Canadian River north of Hinton and is known as the "yellow" bridge that was originally constructed with 38 yellow steel trusses and more than 4000 foot long. This project will replace and widen the bridge deck while maintaining the historical trusses and will be completed in time for the Route 66 Centennial Celebration in 2026. (He showed some pictures of the event and noted that Lt. Governor, Matt Pinnell and Trey Thompson from the Historical Society were in attendance) He also recognized Shawn Davis for the great job he did out there.

He said we have Andrea Ball with the Oklahoma Transit Association here today. I had the opportunity to go attend the unveiling of their one-of-a-kind project at the Scissortail Park last Wednesday. It was the Rolling Oklahoma Classroom bus, which is parked outside the ODOT building today (please go look at it \& take some pictures). It was made possible through a Federal Transit Administration grant through the Oklahoma Transit Association, and partnership with Oklahoma City EMBARK, Tulsa Transit, and the RISE Corporation from Muskogee. This bus is designed to enhance awareness of public transit options in rural, tribal and urban communities and can travel to these areas by request and at no cost. It will also provide hands-on safety and security training for transit workers and address human traffic awareness and prevention across the state. The human trafficking side of it is so important to us, because that's something that the Transportation Cabinet and all the other agencies are committed to combat human trafficking and bring awareness. If you see something that doesn't look quite right, you're always better off to bring that forward and point it out to law enforcement so they can check into it and do something about it. We have got a responsibility to keep an eye out for each other; congratulations to the team for putting that bus and that message together.

Secretary Gatz said our thoughts and prayers go out to Idabel that was hit with a tornado last week. There is really nothing worse than a late fall tornado; and we are continuing to provide assistance to the people in Southeast Oklahoma.

He reminded us that winter weather is upon us; we have a freeze warning with the potential of freezing precipitation coming and we want to carry that safety message to the traveling public. So, one of the tools we use and developed is a new flyer produced to promote preparedness during winter weather storms. The brochure includes a behavioral and equipment check list, number of trucks and crews and materials available, the Road Conditions hotline phone number, road conditions website and a QR code to the Drive Oklahoma app. It will be available at some of our tag agency partners, Travel Information Centers, District and Central ODOT and OTA Offices.

He thanked the Commission for their consideration of some pretty important projects:

- I-40 continuation of our Wrong Way Detection System on I-40 western corridor. It will be installed along 10 key interchanges between the Texas state line and Oklahoma County. It is a $\$ 4$ million project awarded to Action Safety, expected to start early 2023 and complete summer 2023. This is just the next phase of the wrong way detection system, a total of 49 interchanges on l-40 are receiving safety upgrades as a part of these projects, the $1^{\text {st }}$ installation occurred in early 2022 along l-40 between Oklahoma County and the Arkansas state line. A $2^{\text {nd }}$ project is about to begin on the northern l-35 corridor between Oklahoma County and the Kansas state line.
- SH-20 Rogers County realignment and Will Rogers turnpike access point near Claremore. It is a $\$ 64$ million project that will widen $\mathrm{SH}-20$ to 4 and 5 lanes between the Verdigris River and $\mathrm{SH}-66$. The new alignment will run about 2-3 miles south of the current alignment and will include a BNSF railroad grade separation and new interchange on Flint Rd which will be improved and includes a new access point to the Will Rogers Turnpike. This project is estimated to start late 2023 with 2 to $2 \frac{1}{2}$ year timeline.
- US-283 Jackson County shoulders, bridge south of Altus, a $\$ 10$ million project that runs from half-mile north of the Red River to SH-5 junction in Jackson County. It adds 8 -foot shoulders on a 2-lane highway as well as resurfacing US-283 between SH-5 and the Red River. This is a final project in a 3-project series adding 8 -foot shoulders from the state line to Altus.

We have some upcoming events coming up:

- On November $10^{\text {th }}$, we will be in Seiling for a groundbreaking ceremony for the next phase of US270. This will be the next project to continue construction of the "Northwest Passage" which will create a 4-lane divided highway from Oklahoma City to Woodward.
- On Friday, November $18^{\text {th }}$ will be the annual Environmental Excellence Awards Banquet presented by our partner Keep Oklahoma Beautiful will be held at the National Cowboy \& Western Heritage Museum. ODOT and participating communities will be recognized for their efforts in the Keep Oklahoma Beautiful campaign.
- On November 22nd there will be a groundbreaking ceremony at I-40 and Douglas for the new interchange that will soon be known as US Senator James Inhofe Interchange. Senator Inhofe will be present for the ceremony and will be recognized for his efforts to further infrastructure and military expansion in Oklahoma.

NOTE: Commissioner Alexander thanked all employees of ODOT and the contractors for their hard work they put in on the route from Woodward to Oklahoma City. It's been a 20 -year project or more on getting that road done and we are so excited.

Commissioner Grimsley said he made a comment last month that sometimes our Engineers are "Engineering Wizards". Bobby Stem told me after meeting that I couldn't just say that, but I needed something more tangible. So, I have a Wizard Hat to present to Commissioner Freymiller and Division 4 for the remarkable project they completed in 2 weekends here on I-35 in Oklahoma City. They set a very high bar; this award may stay with them awhile, but maybe we can have this as a revolving award when you pull off that amazing wizardry.

Secretary Gatz thanked Commissioner Grimsley for that recognition and that may become an annual award and we'll incorporate that into our innovation.
