 - i. Effective January 1, 2013, there is hereby created the Commission for Educational Quality and Accountability, which shall be known as the Commission for Education Impact effective November 1, 2025; and
 - ii. Staggered terms of the Commission members.
 - B. Proposed change to 70 O.S. § 3-116.3(A) References to Education Oversight Board, Office of Accountability, and Oklahoma Commission for Teacher Preparation
 - i. As of November 1, 2025, all references to the Education Oversight Board and the Commission for Educational Quality and Accountability shall mean the Commission for Education Impact.
